**Grad PLUS Information & Application Process**

The Federal Direct Graduate PLUS is a low-interest credit based loan available to graduate students pursuing Master's and Doctoral degrees and is not subsidized by the federal government. In order to apply:

- **Must have a FAFSA on file to be considered for eligibility for current year.**
- Log on to [www.studentaid.gov](http://www.studentaid.gov) and complete the following (you will need your FSA ID available at [www.studentaid.gov](http://www.studentaid.gov)/fsa-id):
  - Master promissory note (MPN)
  - Grad Plus loan entrance counseling (if you have not already done so)
  - Grad PLUS application and credit check
- **NOTE:** Additionally, completing **PLUS Credit Counseling** will be required by the U.S. Department of Education if you have an adverse credit history and still wish to pursue a loan with an endorser or by satisfactorily documenting extenuating circumstances.

I authorize the electronic transfer of my GRAD PLUS loan funds to apply towards my registration fees FIRST and then other University charges including, but not limited to, short-term loan repayments, and past-due university obligations. I understand that if I do not receive sufficient financial aid to cover these charges, I am responsible for paying any unpaid portion to Student Business Services. I understand that my ability to enroll in classes and University services may be withheld if these charges are not paid. If I am a recipient of a GRAD PLUS loan, I may rescind this authorization with written notification to this office.
