

Orange County Change: Census 2000 to 2010

This profile report contains data from the 2000 and 2010 U.S. Census files for Orange County, California. It includes two-page profiles with numbers and percent shares for 2000 and 2010 total population, population by race/ethnicity, group quarters population, population by age, and housing unit type. At the end of the document are tables showing the numeric and percent change for the same items between 2000 and 2010.

City boundaries in Orange County changed in many areas since 2000 (Map 1) with several existing cities annexing large amounts of land. Aliso Viejo incorporated in 2001 and became Orange County's 34th city.

Map 2 shows the population change by jurisdiction. Since 2000, Orange County's population has increased by 5.8%. The cities with the largest increases were those that annexed the largest areas of land. Lake Forest and Newport Beach annexed areas that had existing development. Lake Forest annexed the communities of Foothill Ranch and Portola Hills. Newport Beach annexed Newport Coast and San Joaquin Hills. Irvine has made several consecutive annexations on which a number of

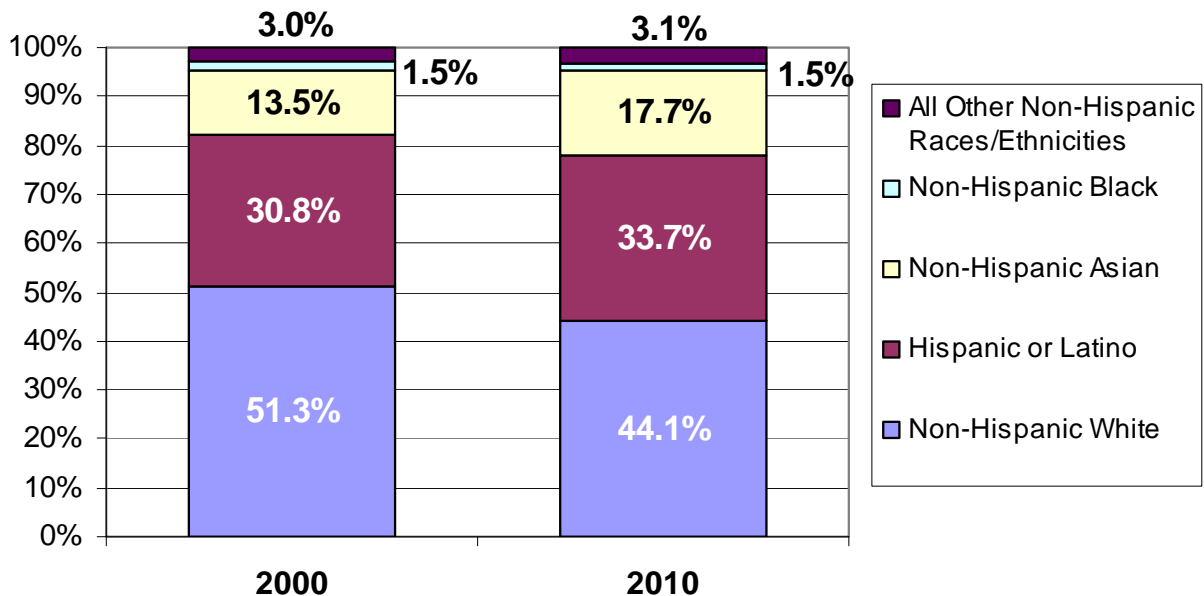
developments have been built. San Clemente also annexed the community of Talega as portions were completed. The unincorporated portions of Orange County collectively "lost" population due to the annexations of land with existing communities.

During the past ten years, Orange County also became a minority majority county when the non-Hispanic white population no longer comprised more than 50% of the county population. All other racial/ethnic groups had increases in population (Figures 1 and 2).

A similar pattern of growth can be seen in the housing unit change as with population change (Map 3). The largest housing unit increases were seen in the same cities with the largest population growth. Unincorporated County shows a loss of housing units because of the annexations of existing communities. There were also sizeable developments in Brea, Orange, Placentia, and Yorba Linda.

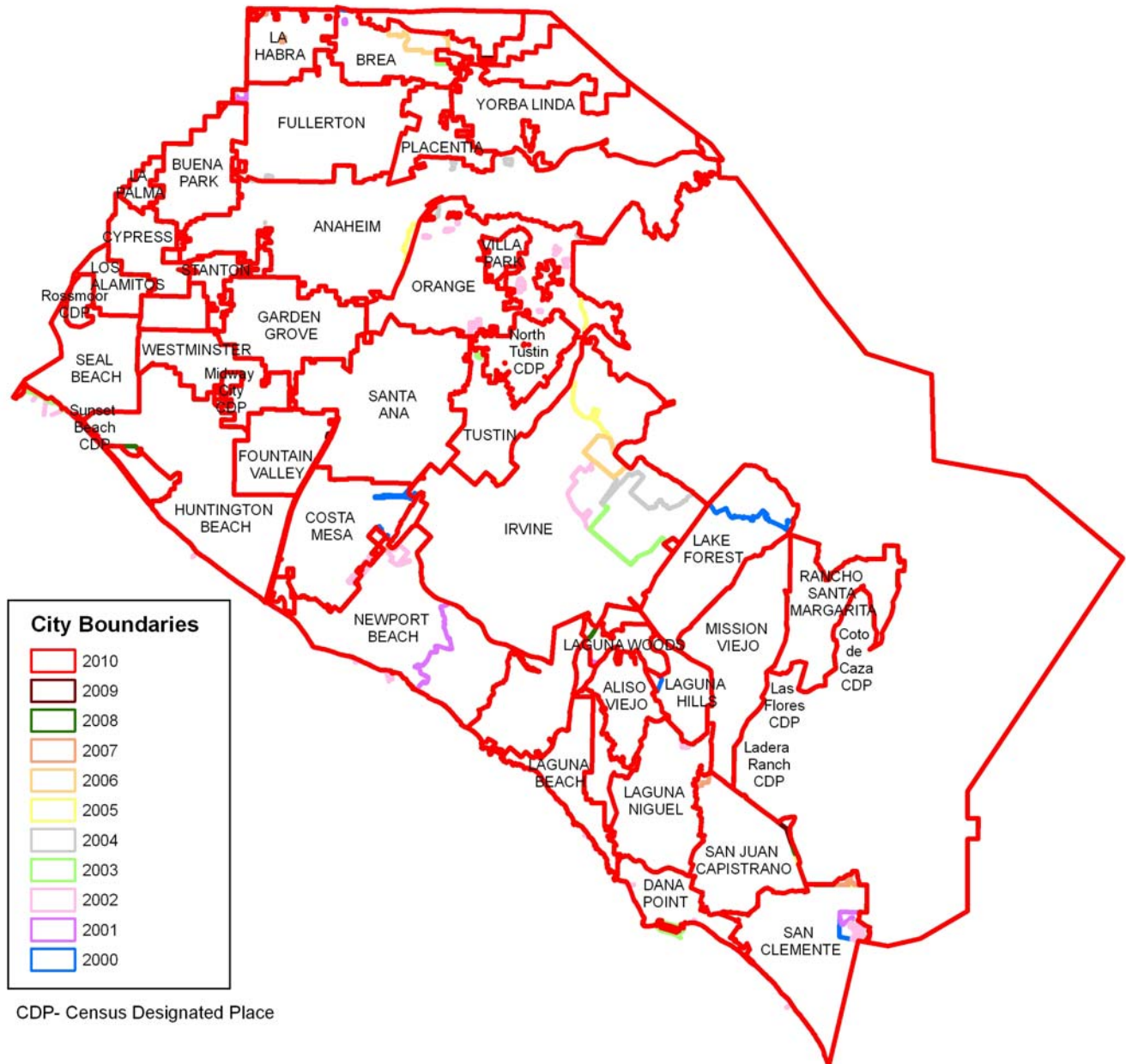
The County's housing inventory increased by 8.2% over the decade (Figure 3). The number of occupied units increased by 6.1%. The number of vacant units increased by 64.1% as a result of the housing market crash.

2000-2010

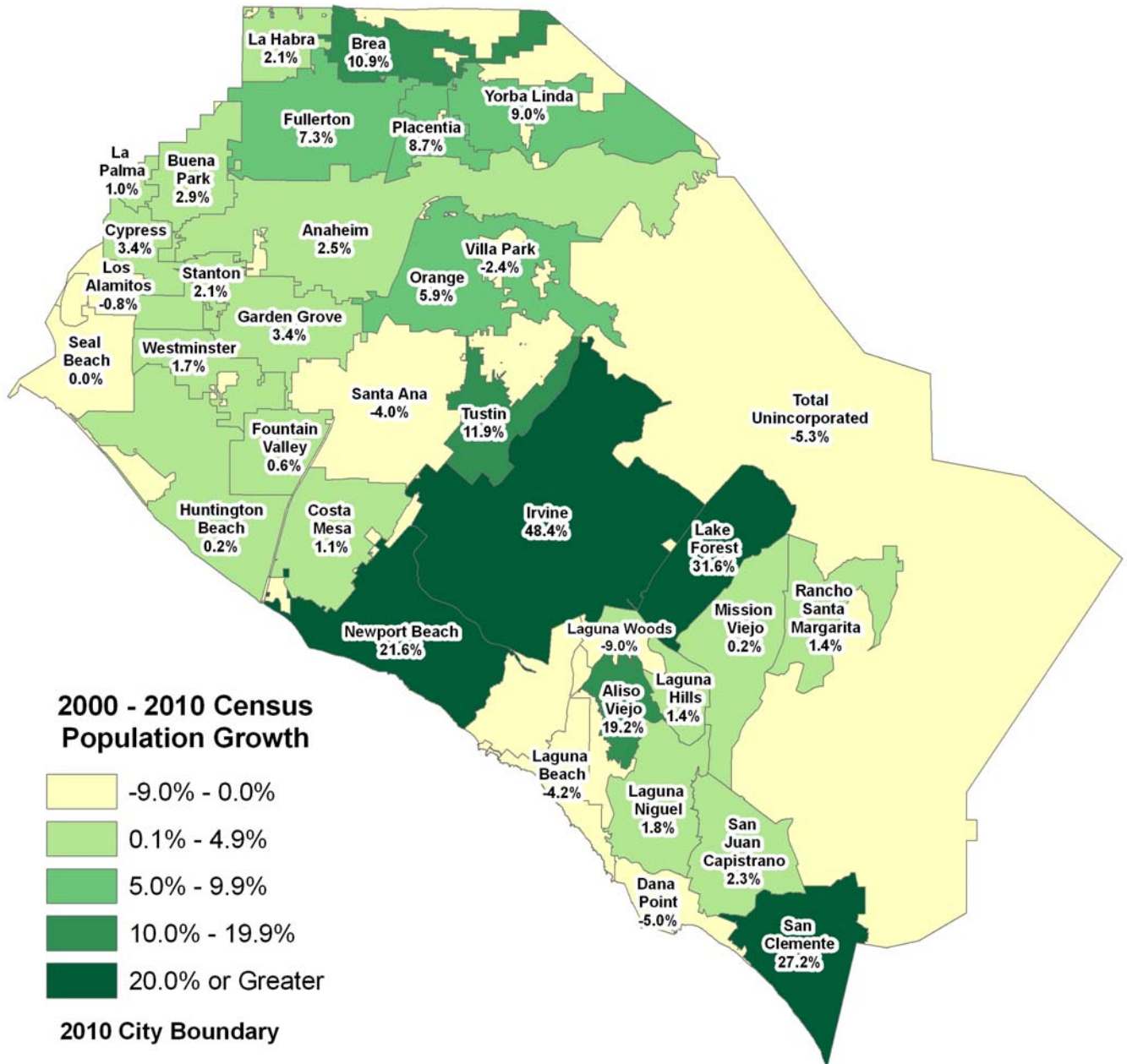

Orange County Population by Race/Ethnicity, 2000 and 2010

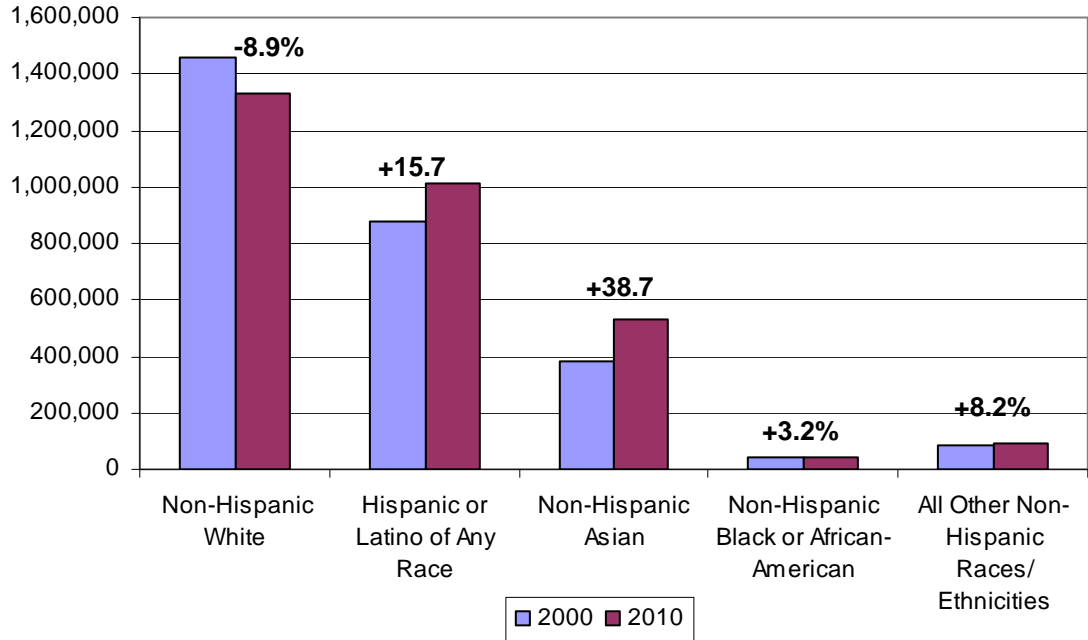
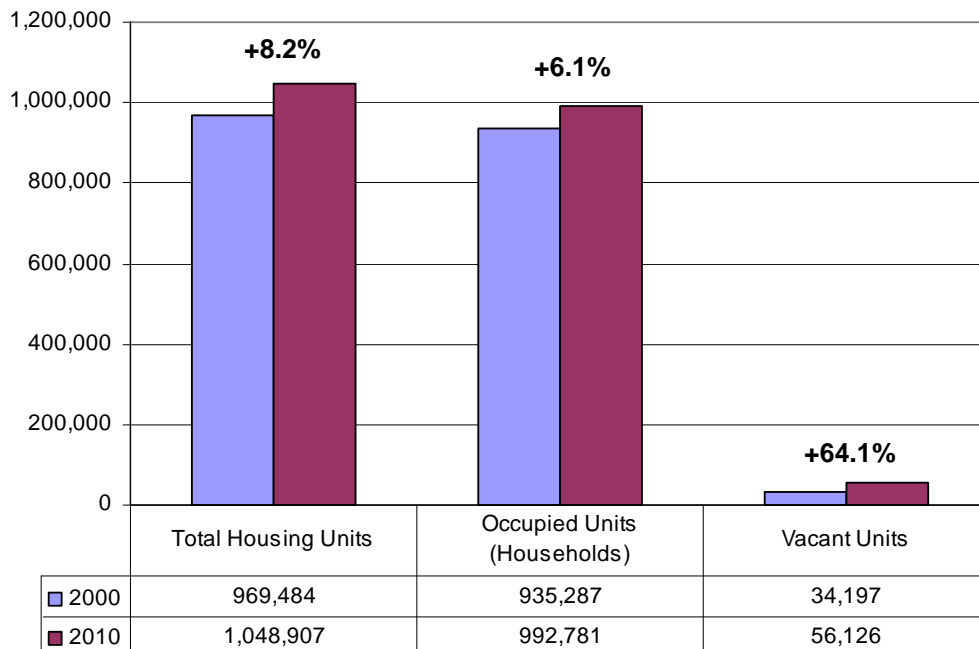
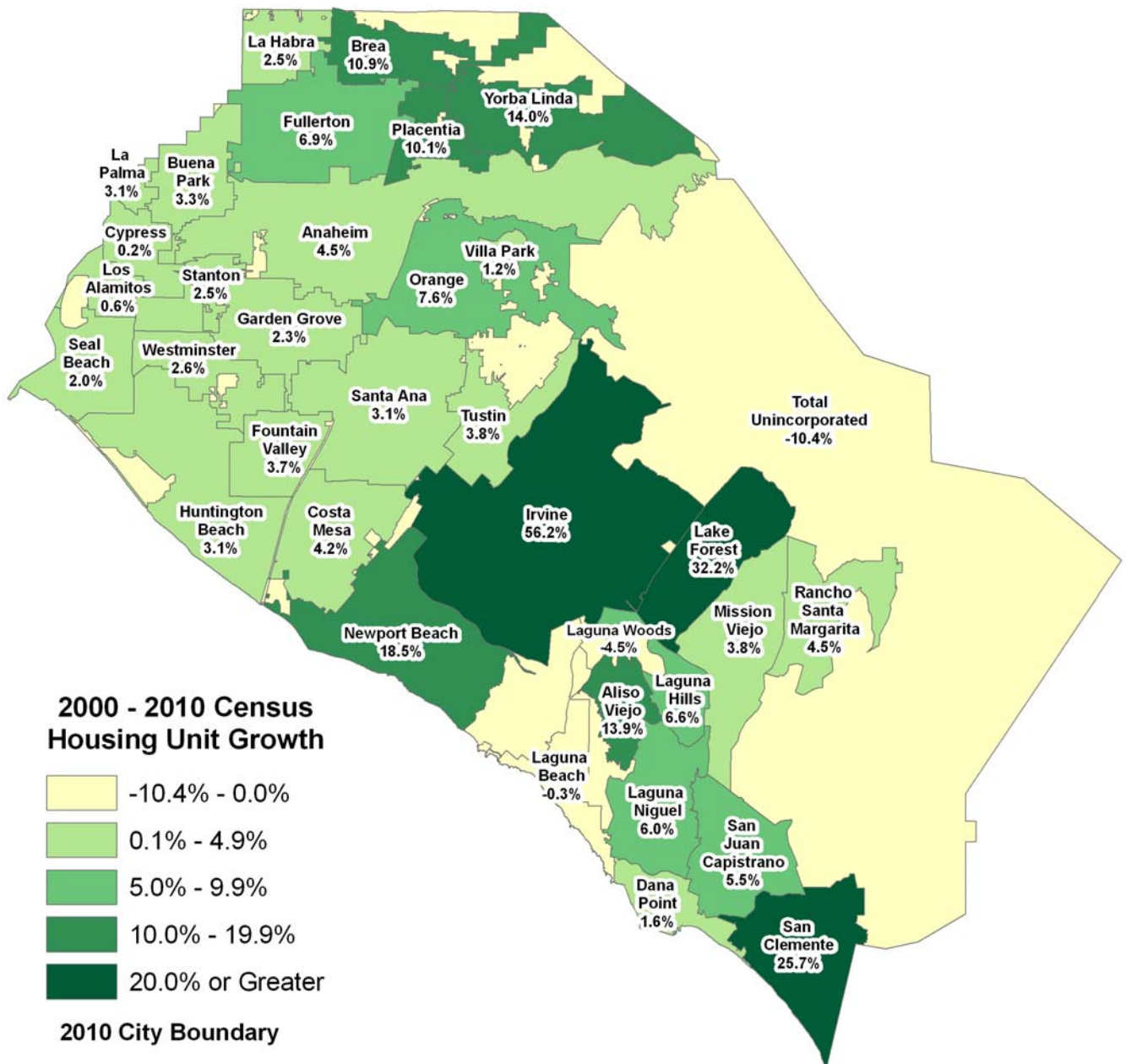

Institutional Group Quarters - Facilities that house people under formally authorized, supervised care or custody in institutions at the time of enumeration. Such people are referred to as patients or inmates.

Correctional - These facilities are operated for correctional purposes and may include correctional residential facilities, federal detention centers, prisons, jails, military discipline barracks, group homes for juveniles, and residential treatment for juveniles.

Nursing - Facilities licensed to provide medical care with seven day, twenty-four hour coverage for people requiring long-term non-acute care. People in these facilities require nursing care, regardless of age.

Other Institutional - Facilities in an institutionalized setting that do not fit into one of the before mentioned categories. They include hospitals with patients who have no usual home elsewhere, hospice, mental hospitals and psychiatric units, and military treatment facilities.

Noninstitutional Group Quarters - Facilities that house people who live in group quarters other than institutions such as college dormitories, military quarters, and group homes.

College - residence halls and dormitories, which house college and university students in a group living arrangement. Fraternity and sorority housing recognized by the college or university are included.

Military - These facilities include military personnel living in barracks, dormitories and military ships.

Other Noninstitutional - Facilities in a noninstitutionalized setting that do not fit into one of the before mentioned categories. They include emergency and transitional shelters, group homes for adults, residential treatment centers, religious and worker group quarters.

College - residence halls and dormitories, which house college and university students in a group living arrangement. Fraternity and sorority housing recognized by the college or university are included.

Military - These facilities include military personnel living in barracks, dormitories and military ships.

Other Noninstitutional - Facilities in a noninstitutionalized setting that do not fit into one of the before mentioned categories. They include emergency and transitional shelters, group homes for adults, residential treatment centers, religious and worker group quarters.

Institutional Group Quarters - Facilities that house people under formally authorized, supervised care or custody in institutions at the time of enumeration. Such people are referred to as patients or inmates.

Correctional - These facilities are operated for correctional purposes and may include correctional residential facilities, federal detention centers, prisons, jails, military discipline barracks, group homes for juveniles, and residential treatment for juveniles.

Nursing - Facilities licensed to provide medical care with seven day, twenty-four hour coverage for people requiring long-term non-acute care. People in these facilities require nursing care, regardless of age.

Other Institutional - Facilities in an institutionalized setting that do not fit into one of the before mentioned categories. They include hospitals with patients who have no usual home elsewhere, hospice, mental hospitals and psychiatric units, and military treatment facilities.

Noninstitutional Group Quarters - Facilities that house people who live in group quarters other than institutions such as college dormitories, military quarters, and group homes.

College - residence halls and dormitories, which house college and university students in a group living arrangement. Fraternity and sorority housing recognized by the college or university are included.

Military - These facilities include military personnel living in barracks, dormitories and military ships.

Other Noninstitutional - Facilities in a noninstitutionalized setting that do not fit into one of the before mentioned categories. They include emergency and transitional shelters, group homes for adults, residential treatment centers, religious and worker group quarters.
