REMINDERS FOR NEWLY ADMITTED INTERNATIONAL STUDENTS FOR FALL 2009 SEMESTER

REQUIRED SEVIS Check-In and Reporting in University Hall-Room 244:

From Monday August 10 – August 19, 9:00am – 11:00am, 2:00-4:00pm

As required by the US Department of Homeland Security, we will need to obtain photocopies of your immigration documents and passport.

Please bring the following photocopies to the International Education and Exchange Office (IEE Office) during the above listed dates and times.

* **List of Photocopies Needed:** (Please be sure that your copies clearly show any date-stamps. Please bring copies AND original documents.)

- Passport pages: showing your photo, date of birth, country of citizenship and passport expiration date
- Visa stamp (page in your passport; obtained at a US Embassy)
- I-94 Departure Record Card – front and back of this card OR Form I-797 Approval Notice for Change of Status
- One of the following:
 - = Form I-20 Certificate of Eligibility for Nonimmigrant (F-1) Student received from Cal State Fullerton (Transfer students will receive their Cal State Fullerton I-20 after first three weeks of Fall semester)
 - OR
 - = Form DS-2019 Certificate of Eligibility for Exchange Visitor (J-1) Status received from Cal State Fullerton
- Only for students who have previously attended another U.S. school: Form I-20 from previous school that you last attended

*** This is a requirement of all international students, both transfer and newly- arrived students. If your file is missing any of these copies, a registration hold will be placed on your record, preventing you from enrolling in, or adding/dropping your classes.**

Transfer of SEVIS Record: Deadline August 15, 2009

The deadline for the transfer of your SEVIS record to Cal State Fullerton is **August 15, 2009**. If you have not yet contacted your previous school to request the transfer of your SEVIS record to Cal State Fullerton, please do so as soon as possible. In order to request the transfer of your SEVIS record, you can submit our Transfer-In Form to your previous school. You can download a copy of this form by going to the following link
