## I. CALL TO ORDER

Chair Jarvis called the meeting to order at 11:30 AM.

#### Chair Jarvis read the statement below:

Following Eileen Walsh's appointment as interim AVP of Academic Programs, her position in the Senate went away, as she was elected out of the Social Sciences constituency, and has now entered the Administration constituency. This means that the position of Chair of the Academic Senate became vacant. Article IV, Section 4 of our Constitution states that the vice-chair shall assume the duties of the chair in the event that the chair becomes vacant before the end of the term. As I was elected vice-chair at our electoral meeting in May, that means I am now the chair of the Senate. This has three implications:

- First, the position of vice-chair has become open, and our first order of business has to be to fill that.
- Second, Senator Walsh remains Senator Walsh. Article II of the constitution lists the immediate past chair as a member of the senate, and as a member of the Executive Committee. However, the seat she had formerly occupied is now vacant, and we will follow our procedures (self-nominations, 10 valid signatures, and a subsequent election) to fill that position.
- Finally, the speed of all of this has led to the rest of us on the Executive Committee failing to draft a resolution thanking her for her service as chair, as is our custom. I do not want anyone to misinterpret this as anything other than a product of the speed of this transition; the other members of Exec will draft a resolution thanking immediate past chair Walsh for her service for consideration at our November 16 meeting.
