#### Additional report:

• (Brown) The CFA Holiday party is on Monday, December 11<sup>th</sup>. I will be sending a reminder out today, if you have not registered yet, please register.

Q: (Bruschke) I've received two emails from the Chancellor, talking about what I should not discuss in class. I understand the CFA and CSU disagree about what that is. How is that going to be enforced on the Fullerton campus? How will those be disciplined, investigated, or discovered?

A: (President) This issue came up and we sought clarification, which is why there are two communications. Of the two, the most recent one starts to clarify the intent of the bullet point. We are in active negotiations, conversations at the systemwide level around contract issues. We recognize that each of the bargaining groups have agreements, understandings about that work.

So, for example, when the factfinder report came out, there was a 10-day period where both parties agreed that we would not be sharing that report. Then similarly when any one group is at strike, we try to create FAQ's, information for people to understand how to navigate these dynamics.

I understand and appreciate the concept of academic freedom and recognize that faculty can and should be in a primary role in determining what is said in the classroom to advance the learning objectives and goals of the class. I also recognize there are important announcements that faculty have to make to their class. I recognize there's also an opportunity to educate students about the situation that we find themselves in. I think what was intended by that later clarifying communication is that the classroom should not be a place where we're advancing one point of view and not creating spaces for students and others to see the broader dimensions and components of whatever issue that is. So, is there going to be discipline? No, I don't think the intent was to create a chilling environment or to in any way halt open dialogue about the predicament that we're in, in terms of contract negotiation issues.

 (Bruschke) I understand no discipline has happened and you said you didn't think there would be discipline. But the chilling effect would be, will my students report on it? Will there be someone from the administration actively trying to find out if I have said something that interrupts or goes outside what the Chancellor considers the scope of class. I appreciate your assurances, I'm still not quite sure how that will be implemented on our campus.

I understand you think it's a reasonable restriction and I understand the CFA disagrees. I just want to know with whatever might get said, will be a matter of interpretation. So, how will that be handled on our campus?

• (President) Right now it will be handled the way all other concerns are, either through an action or a grievance. We haven't received any complaints from students on the issue.
