Q: (Stanley) Did the timeline change at all regarding the Chancellor's decision on AB 928? I don't know if the Statewide Senators go any sense of what's going on with that.

A: (Shepard) The ASCSU passed a resolution at the last plenary, strongly chastising the Chancellor's office to not make any decisions without a resolution by the Statewide Senate taking a position. There are two more resolutions that will come up in November with similar language. The Academic Affairs Committee meet tomorrow to discuss largely these issues. The overwhelming majority of campuses seem to be strongly disinclined to support alignment between the transfer package and GE Breadth.

- (Kanel) There actually is a legislation that says that faculty are the ones to be in charge of curriculum, that was why we did the admonishment, because faculty weren't given meaningful consultative powers as a legislative policy requires.
- (Childers) The Chancellor's office original schedule was to provide information to the CSU Board of Trustees at the November meeting for action in January. Based on the feedback from the ASCSU, their intention is now to allow more time for those discussions to happen, to provide information to the Board of Trustees at the January meeting for possible action at the March meeting.
- This is somewhat problematic for us because it shortens the timeline if there is an alignment, if there are any changes to the GE Breadth, made by the Chancellor's office, this does shorten the timeline to change both policy and curriculum as necessary for alignment on our campus. But at least this gives us more time to provide feedback to the ASCSU and the Chancellor's office on any potential actions.

5. CFA Report

Q: (Henning) Can you give us clarity on what some of the next steps are, now that we are in a fact finding phase of bargaining?

A: (Brown) Fact finding is a place where we'll have a CFA representative, a management representative, and a neutral party, it's almost like a legal proceeding. Each side will present their case, the Factfinder will make a decision. Historically, we have never lost in fact finding and we don't expect to prevail at this time. After fact finding, there will be a blackout period of 10 days. After the blackout period occurs, we can make a last and final offer, management can make a last and final offer, and CFA can do job action.

A lot of people have been asking if we are going to strike this month? At this time, we don't know the timeline, can't predict that.

Other questions people asked, are we going to do a one day strike, a general strike, a moving strike? We don't know and we have to get input from our members before we make that decision. When those times happen, we will be ready and we will start doing some actions here at Cal State Fullerton to inform you where we are and get your input.

Q: (Henning) Is there any action that faculty and staff can take on AB 123, which is to provide a full semester of paid parental leave for CSU employees? It's on Governor Newsom's desk right now.

A: (Brown) This is one of the things we bargained for at it was ignored and the Governor vetoed this bill last time. If you all can contact the Governor's office and let them know this means something to us, this is an important issue.
