Topic: Update on Division of Academic Affairs

Speaker: Steven Murray, Acting Vice President for Academic Affairs

VPAA Murray thanked groups whose members worked diligently over the summer months: 1) Campus Strategic Planning Steering Committee; 2) Executive Committee; 3) WASC team members; 4). University

Faculty Personnel Committee. He encouraged departments to have in place their individual department personnel standards. Every file of faculty member's going up for review from departments not having DPC standards in place is added workload of the campus elected FPC members.

This address highlighted four major areas: 1) enrollment; 2) implementation of impaction plan; 3) budget; 4) tenured/tenure-track faculty hiring. A more detailed presentation will be addressed as the semester progresses.

Enrollments

CSUF opening day headcount was 35,874 (FTEs=28,726). First-time freshmen totaled 4,184, (expected 3,900). Upper division transfer students totaled 3,667 (expected 4,000). Chancellor's Office is allowing 3% over target. CSUF denied admission to 8,000 CSU eligible students (down from 10,000 last year). Managing enrollments is a key goal and an ongoing challenge. CSUF graduated 8,448 students May 2011 (7,882 May 2010).

2. Managing Impaction Plan

Full analysis will be forthcoming; however, we have employed both campus and program impaction. For local area students, the (CSU) eligibility index for first time freshmen was raised from 2,900 to 3,200. Local transfer students CSU eligible GPA requirement was increased from 2.0 to 2.3. Elevations represent the application of program-level impaction. Higher thresholds were also raised for out-of-area students. Campus make-up, diversity, financial status, majors, college numbers have remained stable.

3. Budget

The income generated to campus from tuition and fees paid by students will amount to 57% of our total revenue (45% last year). State subsidy (FTE) per student will be 36% of revenue (48% last year). 7% comes from other sources. It means that head count becomes increasingly important for campus revenue. State subsidy is produced by head count (tuition and fee payments) rather than FTEs. CSUF is able to maintain the high target mark because of excellent management from spring 2011 admissions – a \$20M increase in baseline monies. Those revenues are largely being used to offset budget cuts this year. VP Hagan will address the budget in detail later in the semester.

4. Faculty Hiring

From 60 searches, 44 new tenured/tenure-track faculty were hired last year in 2010-11 (42 college hires, 2 librarians). Between resignations and retirements and losses, there was a net gain of 7.1. We're hoping to achieve 60 searches for 2011-12, which is in line with 75% of FTEF carried by T/TT faculty. VPAA Murray encouraged all departments to move toward these objectives.

VIII. CHAIR'S REPORT

The report was sent prior to the meeting. Chair Bedell highlighted the January retreat event regarding Online Learning.

Academic Senate Chair's Report #1

The Executive Committee of the Academic Senate met seven (7) times during the 2011 summer. We were joined at Times Certain by Drs. Trotter, Murray, Briggs, Fellow, Alcantara and Knutson Miller. In addition, we had presentations by Mr. Jay Bond and Mr. Kim Apel regarding the Campus Master Plan.

Standing Committees, Boards, Search Committees, etc: The Academic Senate Consent Calendar for August 25th contains the Executive Committee recommendations for almost 100 slots on Committees, etc. The Committee Interest Database, especially when "high interest" was indicated, was instrumental in helping us complete this task. I want to thank Executive Committee members Walicki, Dabirian, Walker, Guerin, Walk, Randall, Stambaugh, and Pasternack and Alternates Fitch, McConnell, Meyer, Rhoten, Matz, Chavis, Knutson Miller and Carroll for the hours spent on selecting members for these important service roles. Many hours were spent discussing a proposal by the Communications faculty to partner with the Poynter Institute. Many issues were discussed and the need to follow established CSUF curricula policies was reinforced. Drs. Briggs and Fellow will be preparing an update and summary of fall actions and implementation for the Executive Committee, early fall 2011. (see Executive Committee minutes of May 24, 2011 and July 12, 2011 for greater detail).

Strategic Plan: Drs. Knutson Miller and Alcantara discussed the way to "sunshine" the proposed Strategic Plan which is significantly different than what the Academic Senate reviewed in spring, 2011. There will be several opportunities for campus input (the Academic Senate will host a meeting on 9/1 for this purpose), a campus website and a final opportunity for the Academic Senate to review the document (9/22) after the conclusion of the "input opportunities" before it goes to President Gordon for approval.

Academic Affairs/Academic Senate Retreat on August 16, 2011: we co-sponsored the 11th annual Academic Affairs/Academic Senate Retreat. This year's was on the University Library and its future. We had presentations from our librarians and representatives of the University Leadership Council discussing their national research on trends in university library usage, acquisitions, etc. We had well over 90 in attendance and it was perhaps the largest gathering dedicated to library issues ever held on this campus. The Executive Committee, in conjunction with Vice President Murray, will now take the survey responses and work with the librarians to develop an action plan. The Library Committee of the Academic Senate will also be involved. I want to add my personal thanks to our librarians for the great job they do and also for their instrumental role in making this Retreat a success. You are able to access the Retreat's documents on the Academic Senate website.

Treasurer Dabirian soon will send out a request for a financial contribution to the Academic Senate Faculty Fund. We have used these monies to support faculty during difficult days such as time of illness or family loss. Please make a contribution to help us maintain this tradition.

Each year, the Academic Senate solicits opinions on at least three (3) issues. Last year's issues focused on adding two (2) staff member to the Academic Senate (this received little support), adding a Committee on Sustainability (this received support), installing parking meters at limited time parking spots(this received very little support), and, finally, taking CSUF to a 4 day summer teaching schedule (this received support). N.B. all of these items had large numbers of "neutrals". I am asking this year's Executive Committee to review the whole process of soliciting opinions this way. Historically, we have at times generated policy from their results, such as implementing plus/minus grading.

Each year, we honor a faculty colleague for his or her role in fostering collegial governance at CSUF. We have asked the Outstanding Professor Award Committee to finish its deliberations sooner so that we can honor this colleague earlier in the spring semester so this award is not lost in the hubbub of graduation and the announcement of other awards.
