I. CALL TO ORDER


Meeting was called to order at 11:30 AM.

II. URGENT BUSINESS

(Mead) Asked for possible insight from Senator Hagan (VP/CEO Administration & Finance) regarding the LA TIMES article 11-10-11 indicating possible CSU tuition increase for spring 2012 semester. Vice President Hagan indicated that the Chancellors Office would be proposing a tuition increase with a request that the Legislature buy out the proposed increase, i.e., allocate funds within the CSU budget equivalent to the proposed tuition increase so that the increase would not have to go into effect. Additionally, by putting the tuition increase into the budget early it addresses concerns raised in the past about tuition increases being proposed late in the year, increasing the difficulty of students preparing for it. If the legislature does not buy out the tuition increase, the students know well in advance that an increase may be coming.

V. SPECIAL PRESENTATION

Topic: Information Technology Security Awareness

Speaker: Senator Amir Dabirian, Vice President – Information Technology

The CSU has mandated security training for all campus employees by 12-31-11. This session is acceptable training for all who sign the attendance sheet distributed. Senator Dabirian cited the need for security awareness and the three levels of CSU classifications: Level 1 Confidential; Level 2 Internal Use; Level 3 General. Top 10 Information Security Issues:

Topic: Campus Impaction Update

Presenter: Steve Murray, Acting Vice President, Academic Affairs

VP Murray updated the body on CSUF's guidelines for implementing impaction principles to control enrollments by limiting admission of new students and the results of employing impaction on our fall calls of new students. The system-wide mandates call for controlling FTEs due to the budget limitations and in cases where the demand for enrollment exceeds the campus FTES target. We experienced and learned from the moving targets of fall 2010, that implementation flexibility is needed on admissions of freshmen, undergraduate and transfer students. Our impaction plan, which the Chancellor's office approved for 2010-11 was employed for 2011-12, and will be employed for 2012-13. The two types of impaction are 1) campus impaction; 2) program impaction.

CSUF guiding principles for implementing our impaction strategies:

- Do not inadvertently alter the mix of lower and upper division students and majors;
- Take into consideration the historical balance of freshmen and transfer students and the numbers of students enrolled in campus programs or majors.

Statistics were reported covering fall 2011 admission outcomes, broken down by local and out-of-area admissions as defined and approved by the Chancellor's Office. The report included an analysis of the diversity and academic characteristics of our entering freshmen and upper division transfer class.

VIII. CHAIR'S REPORT

Report by Jack Bedell was sent to Academic Senators electronically prior to this meeting.

At a recent meeting of the Executive Committee, the issue of the "place falling apart" was raised. Broken elevators, unlevel floors, filth, transformers popping, etc., were among topics raised. In response, we visited with Vice President Willie Hagan and Mr. Willem van der Pol to hear plans about corrections, infrastructure repairs needed and associated costs. It is our understanding that the administration is going to propose to PRBC a plan for some improvements. It seems that given the average age of 39 years for a CSUF building, emergencies come up that derail proposed improvements. In addition, the amount for deferred maintenance in the total CSU budget would hardly make a dent in CSUF's needed improvements. We'll keep you posted as we hear more. Please let the Academic Senate office know of things you think need to be done.

Our University community is currently involved in discussions about the Campus Master Plan which focuses on future construction to support future enrollment. There is significant support for increasing green space. Please try to get involved in these conversations. Or, go to the website which has been created to receive feedback on the Campus Master Plan. The Academic Senate will hold future discussions about the Campus Master Plan, and we expect our new President to be involved as well.

Also, the <u>Collegetown link</u> will give you more information on that effort and an opportunity to give input. The Academic Senate meeting tomorrow will have a report on campus impaction and a security awareness presentation (Academic Senate Chambers, Bookstore; 11:30 AM). New Business includes a Bylaw change adding non-curricular issues of sustainability to our Campus Facilities and Beautification Committee and consideration of endorsement of University-wide Student Learning Outcomes. These have already been endorsed by the Executive Committee, the Curriculum Committee, the General Education Committee, and the Graduate Education Committee.
