ASD 12-126 BOT Agenda Item: Discussion of Proposed Elimination of 9 Units of Upper Division General Education and Reduction of Lower Division Units as well

Chair Bedell announced revision to this item (proposal to eliminate 9 units of upper GE) on the Board of Trustee's 9-18-12 agenda. This originally focused on reducing upper division general education in high-unit majors, as well as changing general education in lower division. He gave background according to his understanding at this time. A flurry of activities happened this past week. ASCSU Chair Guerin communicated with the Chancellor's office, meetings were attended, emails back and forth, resolutions among other Statewide Academic Senate Chairs all focused on removing this agenda item from the Board of Trustees meeting.

The combination of activities resulted in an alteration or withdrawal of the original proposal to reduce general education units. The item has been changed to discussion of how to bring more and more degrees to 120 units, which was the original intent just a few weeks ago.

Chair Bedell used this *GE conflict with BOT* to highlight the extreme importance of moving swiftly with faculty assessment of student learning and our general education program. The 7-3-12 WASC Action Letter indicated discontent with CSUF's assessment of general education, student learning from general education, and the effectiveness of a general education program. If we had effective data indicating the value of general education to our students, CSUF's position would have been stronger to argue to maintain general education units. We will watch closely what actions may be necessary in the future.
