## I. CALL TO ORDER

## II. URGENT BUSINESS

There is an increased need during particularly stressful times, such as final exams, holidays, etc. Hiring additional counselors may be prudent.

  - The ad hoc group on streamlining the course approval document opens this week. I expect to have its recommendations on a February agenda. We have also been told the course proposal document is now in an electronic format for the ad hoc group's review. The goal is to examine every section of the form to determine whether the information requested adds value beyond the content of the syllabus attached to the form.

#### **VIII. CHAIR'S REPORT**

#### Agenda Topics

As we come to the end of the fall semester, your Academic Senate has three (3) meetings left and a very full Agenda. Topics such as University Learning Outcomes, the creation of a Standing Committee on the Assessment of Student Learning, and UPS revisions will occupy our time. I believe it was Sophocles who said "One must wait until the evening to see how splendid the day has been".

#### <u>Welcome</u>

This Thursday, we officially welcome our newest Academic Senator, Dr. José L. Cruz, Provost and Vice President for Academic Affairs.

#### **Farewell and Special Election**

Academic Senator Chris Manriquez resigned to become CITO at our Dominguez Hills campus. He occupied an at-large seat, so we have to have an election to find a replacement for his term which expires in May, 2013. Petitions, with instructions, are available in the Academic Senate Office, MH-143. *Time sensitive*.

#### **Education Merger of 2 Departments**

The group studying the proposed merger in the College of Education – departments of Reading Education and Elementary and Bilingual Education – is about to finalize its report pursuant to UPS 100.605.

#### 120 Units to Degree

Statewide, there is a very strong push, especially driven by our Board of Trustees and the Chancellor's Office, to get as many degree programs down to 120 units as possible. The Academic Senate Executive Committee has discussed this "push" and will be preparing a Resolution for the Academic Senate to consider this month. Speaking for myself, I am concerned that the emphasis on "getting them out" is going to result in a loss of some of the richness of the students' educations.

#### **Question**

Which academic program has the highest % of female students? Of male students? Answers below.

#### Campus Safety

The Executive Committee has received data regarding traffic incidents, tickets issued, etc., with a special emphasis on the Commonwealth Ave/Nutwood/Folino Drive areas. Citations are up dramatically this semester. Some added signage is coming and perhaps more curbs painted red. City of Fullerton is "resistant" to adding signage for "no right turn on red" signs. No skateboarding is allowed on campus (TRUE <sup>©</sup>). The Executive

Committee will meet again with relevant parties in spring semester, and thanks to Chief DeMaio, Jay Bond, Joe Ferrer and Bill Barrett for their responsiveness to this issue. Also, Senator Phil Armstrong, our Campus Facilities and Beautification Committee Chair, has been involved in these conversations.

#### **Assessment**

We shall be holding two (2) open hearings next week regarding the proposed creation of a standing committee on assessment of student learning. Information to follow.

  - M/S (Filowitz/Matz) ASD 12-158 had been moved for approval. The following paragraph is added from A.S. approved minutes 10-29-12.

#### 10.1 ASD 12-158 UPS 300.010 Final Grade Reporting [6-17-05] [Source: ASC]

M/S (Filowitz/Matz) Moved revised document ASD 12-158 for approval.

M/S (Fidalgo/Fitch) Line 12-17. After discussion and generic wording offered, the following amendment to paragraph #1 was determined "friendly". Wording will be as follows:

Faculty members have the responsibility to provide careful evaluation and timely assignment of appropriate grades for courses that they teach each term. The faculty members shall record grades-electronically-in the <u>Student Information System</u>. Faculty Center of their CSUF Faculty/Staff portal under the Titan Online tab. Instructions on how to enter and submit grades can be found in the Online Grading Training Guide in the CSUF portal. Grades shall be due on the date announced in the academic calendar, which shall be no fewer than six days after the last day of final examinations.

(Pasternack): Line 15: friendly amendment to replace on to "by the date announced..."

Debate continued regarding the due date for grades and the term "no fewer than six days". Motion to adjourn meeting 10-29-12.

(Fitch) Lines 15-20 – *friendly amendment* - section with strikeouts/deletions; with better understanding of intention, there was consensus that last sentence in first paragraph should remain as written [moved to Lines 15-16]. <u>Fall semester grades shall not, in any case, be due before January 2</u>. This action was determined "friendly".

(Pasternack) Lines 32-33, *friendly:* replace "intersession and extension with <u>through University</u> <u>Extended Education</u> except that the......"

Vote (by voice): ASD 12-158 was unanimously approved as amended.

ASD 12-172 Report on Course Overlap: Electrical Engineering and Computer Engineering [Source: Grad Ed Com]

Chair Bedell read from <u>UPS 411.102</u> Curriculum Guidelines and Procedures: Academic Jurisdiction the following article III.3 "When a challenge cannot be resolved to the satisfaction of all parties, the University Curriculum Committee, General Education Committee, or Graduate Education Committee shall then hold an open hearing on the challenge, to which all interested parties shall be invited. Chair of the Graduate Education Committee, Senator Penny Weismuller, gave a detailed outline of the process followed according to UPS 411.102. The Report document, ASD 12-172, involve agreement in findings from both the 2011-12 Graduate Education Committee as well as the 2012-13 Graduate Education Committee that there is justifiable course overlap in this new ECS proposed degree program – Integrated B.S./M.S. Degree in Computer Engineering.

M/S/P (Bonney/Huizinga) made a motion to approve Report ASD 12-172 – Recommendation from Graduate Education Committee.

Chair Bedell explained the procedure to be followed so that everyone in the room will be able to speak to this motion. Senators  $-1^{st}$  time speaker's list, then to the gallery, back to Senators to speak to the issue of course overlap. We will not yield.

There was discussion and debate regarding course overlap issues. Senator Michalopoulos suggested newly-appointed Provost Cruz meet with the departments of Electrical Engineering and Computer Engineering to arbitrate course overlap differences. This idea was not pursued.

Professor Hassan Hashimi, Chair of Electrical Engineering Curriculum Committee, used a PowerPoint presentation to speak to the body regarding course overlap issues. The essence of this presentation rejected the Graduate Education Committee Report findings.

(Carroll) Motion to end debate (not debatable). Vote (by voice) motion to end debate passed. Vote (by voice) ASD 12-172 was approved.

12.2 moved from 12.1

ASD 12-173 Integrated B.S./M.S. in Computer Engineering [Source: Grad Ed Com, PRBC] M/S/P (Dabirian/Bonney) Motion to approve ASD 12-173. This is an add-on to a pre-existing bachelor's degree approved many years ago. There is a demand for this innovative degree, which is a pathway/option for students and an opportunity to expand our graduate programs at CSUF. There was discussion and a final vote.

VOTE (by voice) passed ASD 12-172 unanimously. Chair Bedell thanked all departments involved for the energy expended throughout the process, showing a commitment to students and the university.

ASD 12-159 <u>UPS 300.013</u> Late Add Policy [6-17-05] [Source: ASC] M/S/**P** (Filowitz/Stang) Motion to approve revisions to UPS 300.013. (Pasternack) Line 29 *friendly* amendment to strike the word "<del>extenuating</del>". Vote (by voice) Approved ASD 12-159 unanimously.

#### 12.4 moved from 12.3

ASD 12-160 UPS 300.015 Repetition of Courses [6-7-12] [Source: ASC] M/S (Filowitz/Stang) UPS 300.015 policy revisions were approved by A.S. spring 2012; however, comments were returned to the Academic Standards Committee asking for further review and possible revisions with a report back to A.S. spring 2013. Policy has been reworked for clarity and also added a correction to the referenced Executive Order.

(Pasternack) Line 1: *friendly amendment:* add a title to first section "Grade Forgiveness". (Jarvis) Lines 3, 7 and 18: *friendly amendment:* capitalize "GPA"

(Hewitt) Lines 12 and 22: friendly amendment: change word "term" to "semester".

M/S (Dabirian/Fidalgo) Line 21-22: Motion to delete the timeline as follows: "...appropriate form available from A&R and returning the completed form to A&R." end sentence – delete the rest of sentence. no later than the end of the term immediately following completion of the repeated course. There was debate on this deletion.

(Hewitt) Lines 12-13 and 20-21 *friendly* amendment to motion to also delete sentence following A&R. strike "The student must complete and return the form to A&R no later than the end of the semester immediately following completion of the repeated course."

M/S (Randall/Puri) amend the amendment – Lines 11-12 and 20-21: leaving in the timeline to read as follows:

"The student must complete and return the form to A&R no later than 1 year following completion of the repeated course and prior to graduation." This would allow students more time but hold the student responsible to submit necessary the appropriate form. Discussion continued until the end of session. ASD 12-160 will continue under *Unfinished Business* on the next agenda.
