M/S/P (Stang/Walicki) Motion to approve the Proposed School of Music. Senator Stang chaired the ad hoc committee and thanked members for their commitment and efficiency. Committee members were recognized. Dean Arnold was invited to speak on behalf of the College of the Arts. He stated this proposal is recognition of accomplished fact. The use of the term *School of Music* refers to a body of a certain size, complexity, comprehensiveness and professionalism. A *School of Music* will be extremely important for branding and fund raising potential.

VOTE (by Voice) Motion to approve the Proposed School of Business was passed unanimously.

Senator Smith made the following announcements:

- ASI has recently approved \$115,617 to purchase and install an outdoor LD message board to be placed on the west-facing wall of University Hall on top of Student Financial Services blue awning area.

#### XII. NEW BUSINESS

12.1 ASD 14-79 <u>UPS 211.100</u> Appointment of Department Chairs & Vice Chairs [3-25-08] [Source: FAC] M/S (Bonney/Jarvis) Senator Bonney spoke on behalf of Faculty Affairs Committee regarding revisions prompted, in part, by the decision of the arbiter in a Fresno case that, while not binding to our campus, made it was clear it would be appropriate to expand the enfranchised faculty as is also required by terms of the CBA which defines (all) faculty to include part-time faculty. This gave opportunity to clean up other areas in UPS 211.100. There was a subcommittee that was part of this project along with much hard work of FAC members. Senator Bonney walked through the document's revisions and streamlined language.

Senator Jarvis (seconder) spoke as a member of sub-committee to the spirit of the document to operate under constraints of CBA and the arbiter's decision. The first principle was to enfranchise part-time faculty in the voting process.

M/S/P (Pasternack/Mead) Motion to amend line 14. Delete parenthetical phrase (including FERP faculty during their period of active employment). Replace with the following sentence which is the contract language: "For this policy FERP faculty during their period of active employment are considered tenured faculty."

VOTE (by Voice) Motion to amend language to above was approved.

(Pasternack) Pg 3, E.2.a., Line 87 *friendly* amendment would read "All FT temporary probationary and tenured faculty shall have one vote."

(Buck) this appears in two places, so the change should be made in two places.

M/S (Pasternack/Weismuller) E.2.b., Line 89: "All PT temporary faculty shall have a vote proportionate to the annual contractual time base" will be changed as follows "All PT temporary and FERP faculty not in active employment....." This change will enfranchise FERP faculty the same level as lecturers are enfranchised when teaching an annual teaching load. Debate.

Chair Walker offered a suggestion to help alleviate confusion regarding definition of FERP faculty throughout the document since they are considered tenured/tenure-track faculty.

Pg.1, Sentence beginning on Line 12 through 14. The body agreed this suggestion is *friendly*. FRIENDLY AMENDMENT Line 13, 3<sup>rd</sup> sentence in I.: Change sentence to read:

In this document, "department faculty" refers to all temporary faculty, probationary faculty, and tenured faculty. (including FERP faculty during their period of active employment). In this policy, FERP faculty are considered tenured faculty."

This changes the Pasternack/Mead motion (above) and removes references to FERP faculty in other areas throughout the document because they will now be considered with tenured faculty.

M/S (Randall/Perez) proposed amendment to E. Election Procedures, Line 89 E.2.b. add a sentence: "<u>The</u> department may choose to establish a minimum time base of 4 and a minimum employment duration of 1 year as criteria for enfranchising part-time faculty." This amendment relates to part-time faculty.

(Jarvis) Considered *Friendly* motion to amend proposed Randall/Perez motion. "<u>The department may</u> choose to establish a minimum time base of 4 and/or a minimum employment duration of 1 year as criteria for enfranchising part-time faculty."

Would give departments flexibility.

(Carroll) Proposed amendment to streamline the Randall/Perez motion. End sentence at time base to allow flexibility to department to decide minimum time base.

"The department may choose to establish a minimum time base. of.4 and/or a minimum employment duration of 1 year as criteria for enfranchising part-time faculty."

This was determined to be *friendly*.

Chair Walker stated, as a member from the ad hoc group, the logic was to use the same method as given in the Faculty Hearing Panel. A full vote is given when teaching more than 15 hours per year and ½ vote if teaching 15 or fewer hours per year. If it is good enough to enfranchise people who could impact people's employment, it would work to enfranchise for voting since arbitrator did not speak to time base. There needs to be a thoughtful process in how we treat our colleagues.

There was much debate regarding parity, disparity, time base, entitlements of lecturers, semester contracts. A point was made that departments must give a proportional vote according to this document. The department is given flexibility to set a threshold.

(Michalopoulos) Motion to end debate. A 2/3 vote is needed to end debate. VOTE (by Voice) motion carries to end debate.

Motion to call the question.

Senator Randall was asked to re-read the amendment with the Carroll *friendly* amendment. Read: "<u>The tenured and tenure-track faculty in the department may choose to establish a minimum time base</u> and/or duration of employment as criteria for enfranchising part-time faculty."

There was confusion on this amendment, but a vote was taken with the removal of  $\frac{\text{of.4-and/or.}}{\text{VOTE}}$  (by Voice) on the Randall/Perez Carroll motion was not clear. VOTE (by Division) The count with a show of hands: YES = 11 NO = 22. MOTION FAILED.

E. Election Procedures. E.2.b. Lines 89-90 read as follows: "<u>b. All part-time temporary faculty shall have</u> a vote proportionate to the annual contractual time-base rounded up to the nearest tenth."

Back to main document.

M/S (Carroll/Fitch) E. Elections Procedures, Lines 103-111 Motion to strike entire E.5.b. and E.5.c. so that full-time and part-time faculty votes would be reported separately. Debate.

(Michalopoulos) Motion to adjourn. VOTE (by Voice) Motion to adjourn FAILED.

Back to Carroll/Fitch motion on the floor to strike Lines 103-111. VOTE (by Voice) Motion is approved to strike Lines 103-111 E.5.b. and E.5.c.

(Rhodes) Motion to adjourn. VOTE (by Voice) motion approved. Item 12.1 will continue under Unfinished Business on A.S. Agenda 5-8-14. Items 12.2 through 12.4 will be moved to next A.S. Agenda.
