TOPIC:	2014-15 Progress on Assessment at CSUF

	Su Swarat, Director of Assessment and Educational Effectiveness		

Chair Walker welcomed the above three presenters who updated the body regarding progress on assessment and on the many campus-wide presentations over the past 6 weeks that ended last week. AVPAA Nwosu underscored what has been accomplished since spring 2014 through the office of Assessment working with the A.S. Academic & Educational Effectiveness Committee. A product outcome of this work among faculty and also staff in specific divisions is the University Assessment Report, available on the Assessment Website.

Dr. Swarat presented a graphic summary using PowerPoint of a 6-step assessment process that is the framework guiding assessment work using UPS 300.003 University-wide Student Learning Goals and UPS 300.022 Assessment of Student Learning Outcomes at CSUF. Through these two A.S. approved documents, a common language has been established for ongoing discussions, with the scope of assessment expanded from academic units only to university wide. Every person across campus units affects student learning, and hence should participate in the assessment effort. Division of Academic Affairs has provided each college with a faculty assessment liaison as a link to help departments move forward within the assessment network. The following points were highlighted:

- Assessment Website has been established and a timeline identified for the assessment process. Encouraged a visit at <u>www.fullerton.edu/assessment</u>
- Compliance Assist, an assessment Management System, is adopted to document assessment activities and results, and help report assessment efforts at various levels. It has the capacity to assist annual report development, PPR, and accreditation for the future – a one-stop shop at all levels. This tool will replace the annual assessment report and will be fully rolled out in stages.
- Workshops are planned for continuing training and learning.

Dr. Oliver discussed the Assessment Report created jointly from the Office of Assessment and Educational Effectiveness (within Academic Programs) and faculty members serving on the A.S. standing committee of <u>A</u>cademic <u>E</u>ducational <u>E</u>ffectiveness <u>C</u>ommittee. This report is posted on the Assessment Website.

Dr. Oliver spoke as a faculty member regarding what assessment is, what it is not, where it comes from, and what it is used for. Assessment at CSUF has been ongoing for many years for student learning outcomes within departments and programs, but university-wide systematic documentation has been lacking. In spring 2014, the Office of Assessment, in collaboration with the AEEC, developed and administered a survey to collect information on the assessment activities and results from 2012-2014. There were a high percentage of responses -- 60 departments/programs completed the survey, and each response was read. The data were aggregated to generate a summary of assessment at CSUF as a whole. Individual feedback was sent to each department/program, in order to encourage conversations about assessment at the program/department level. It is the choice of each department or program what data and measures to use to determine student learning outcomes. Survey results are also used as basis for professional development.

Dr. Oliver emphasized that this report is not assessment. Assessment is what a faculty member does in their respective classroom or what a program does to measure student learning. The report is an aggregated summary only. What matters is what our students learn.

There was further conversation in a Q/A session.

We've been asked to provide input on student success fees by the Student Success Fee work group that has been formed by the Board of Trustees. In particular, the group wants input from the Campus Senates and others (who have also received the memo and been asked to provide feedback). We have very little time as comments are due by October 13.

The charge of the Trustee Student Success Fee work group is "to study and present findings on the following":

- 1.) The process and history by which category II campus-based mandatory fees are enacted and the approval process;
- 2.) The notification process by which the Board of Trustees and chancellor are informed of category II fee discussions on campuses;
- 3.) The accountability and outcome reporting process to the stakeholders of category II fees to include, the Board of Trustees, students, faculty and staff and the public at large;
- 4.) The impact of category II fees on student success and affordability;
- 5.) The inequity of category II fees across the 23 campus system, with an additional overlay of racial, socioeconomic and academic readiness data.

In an effort to collect and collate feedback from the Academic Senate in a manner that promotes feedback, we decided to collect remarks from senators anonymously using Google Docs. ## IX. STATEWIDE ACADEMIC SENATE REPORT

Senator Guerin spoke on behalf of ASCSU Senators Jarvis and Walker. Virtual meetings of Statewide Senators will be held Friday, 10-10-14. A notice has been distributed regarding reestablishment of the Wang Award which is a CSU outstanding faculty award with a stipend of \$20,000. Many of our Cal State Fullerton colleagues have received this award in past years, and, hopefully, we will once again be competitive.

## X. ASI REPORT

Senator Green announced two items of interest to the A.S.:

- The University Affairs Committee, a standing committee of ASI is undertaking a project to support six (6) heavily represented social groups of CSUF students. There are plans for committee members to reach out and receive feedback from those students' CSUF experiences. ASI committee members will also reach out to colleagues within areas providing resources and services to these same groups of students to try to coordinate support to work together toward student success.
- ✓ The Environmental Sustainability Committee has proposed to the TSU Governing Board "Brown is the New Green" campaign to bring attention to the California's drought. The committee wants to begin with a prime spot... watering grass only twice a month in front of the Titan Student Union. If approved, students on this committee desire to expand the campaign to other campus areas where grass would be watered less and allowed to turn brown conserving water and highlighting the seriousness of saving California's vital resources.

Senator Ansari reported on the following:

- ✓ Moving forward on a nationwide search for a new Children's Center director. Faculty, staff and students will serve on this search committee.
- ✓ ASI Board of Directors approved external audits for the TSU and Titan Student Centers.
- $\checkmark$  Moving forward on the TSU expansion.
- October is official Hispanic Heritage Month. ASI is a co-sponsor of the many planned events that are posted on CSUF website.

## XI. CFA REPORT (Hassan)

Senator Hassan gave an update on the contract negotiations. The current contract expired 6-30-14 and was extended to 9-30-14. No settlement was reached at joint meetings September 18-19. There is another meeting today and tomorrow to try to reach a settlement. Salaries and work load are the major issues being negotiated with other items such as equity increases, inversions, compression and stagnation. Senator Hassan stated his opinion that labor relations between CFA and CSUF administration are at an all-time low.

Chair Walker will return this to Executive Committee to determine where this language should be inserted into the AS Bylaws. "(2) Because these matters may overlap with those of other academic senate committees, the FAC shall consult with the relevant committees."
