Subject: ASD 14-152 Engineering & Computer Science – Request Exception to 120 Unit Cap Presenter: Susamma Barua, Associate Dean, Engineering & Computer Science

Associate Dean Barua shared a 21-slide PowerPoint presentation for the discussion of the Chancellor's mandate for 120 unit cap for all undergraduate degree programs, including programs within the College of Engineering and Computer Science. The ECS responsibility is to create the best 120-unit curriculum that meets accreditation guidelines and is also consistent with the other CSU campuses. Rigor of ABET accreditation and the reputation of the CSUF ECS programs is extremely important. The presentation included ECS commitment to ensure general education and student learning goals and those that ABET requires. ECS undergraduate programs currently require the following units:

ECS needs 9 unit accommodations for its undergraduate programs. The proposal is to allow exceptions for general education in the following areas:

This proposal was carefully reviewed and consideration given to unit requirements in the major and the challenges for ECS program criteria as well as ABET accreditation requirements, global competition, and industry demands and expectations of employers. The proposal reflects a combination of changes made at several other CSU campuses.

Approval from our campus colleagues is requested to meet the mandate of the Chancellor's Office and Board of Trustees.

M/S (Cruz/Bonney) Motion to approve ASD 14-152 ECS Exception Request to 120 Unit Cap. Senator (Provost/VPAA) Cruz spoke on the presentation and the difficult deliberations at hand. Quality of program will be maintained. He stated his full support of this proposal.

The meeting ended with debate amongst the body. Item will continue as unfinished business at the next meeting on 10-30-14.
