I. CALL TO ORDER

Chair Walker called the meeting to order at 11:32 AM.

IN MEMRORIAM

- John G. "Greg" Pierce, Professor Emeritus of Mathematics [died 1-28-15, age 73]
- Wilma J. Traber, Professor Emeritus of Nursing [died 1-6-15, age 88]

II. URGENT BUSINESS

- Senator Kanel asked IT to speak to the issue that printers are no longer being provided for faculty and administrative support staff. Senator Dabirian spoke to the concerns that were addressed three years ago when printer support began to diminish due to budget cutbacks. Division of IT considers need and efficiency when replacing printers. Departments should ask IT when a replacement printer is needed. Requests are considered on a case-by-case basis. Let Senator Dabirian know directly when intervention may be needed. Faculty and staff are important.
- Senator Fitch brought up the issue of campus parking, which has become difficult. VPAF Kim spoke to concerns. His office is actively seeking how to increase spaces and efficiency, especially during mid-day. Another parking structure will be needed in the future. Also, CSUF is working with the City of Fullerton on peripheral lighting, which will provide more safety for people parking in lots farther away from mid-campus.
- Senator Randall stated that the paid (metered) parking row at College Park is mostly unused. Those areas could be better utilized or repurposed. More handicapped spaces are needed at College Park.
- Senator Gradilla suggested some modifications to recent announcements/notifications sent to the campus community regarding sexual assaults on campus. The campus is finally being notified of these incidents now so there is a perception that they have increased. There is work to be done regarding education without perceived judgment to the victims. VPAF Kim reminded the body of the need to comply with Title 9 as well as The Cleary Act, which requires all colleges and universities that participate in federal financial aid programs to keep and disclose information about crime on and near their respective campuses. The format of police bulletins is governed by the Cleary act, which must include tips on how to avoid being victimized. Title IX crosses all divisions. There is a campus committee (AF, SA, HRDI) working with a national consultant dealing with Title 9 and The Clery Act. In future communication alerts/bulletins, attention will be given to language format to meet governmental requirements with sensitivity toward the victims.

VII. PROVOST REPORT (Provost Cruz)

- WASC Interim Report: Thanked all who submitted comments to date, and reminded everyone today is the deadline to submit feedback. Your comments will help strengthen the final interim report to be electronically submitted to WASC 2-25-15. The WASC deadline for this report is March 1st.
- Academic Master Plan (AMP). President García is moving the campus forward on this PRBC recommendation for an AMP. A proposed framework for how we will conduct conversations will be shared in the next several weeks with the campus community.

X. CFA REPORT (Senator Hassan)

Specific salary details known at this time for Unit 3 faculty within the complex CFA contract were reported (4 types to be paid and the dates of payment). Because of the complexities, this has taken time for Administration to work through. President García has committed to negotiating a Campus Based Equity Program which will affect primarily tenured and tenure-track faculty. Criteria will be negotiated between President García's Administration and the Fullerton Board of CFA.

XI. UNFINISHED BUSINESS

11.1 ASD 15-02 Review of Revised UPS 100.001 AS Bylaws in Outline Format [Source: Exec Com] Chair Walker framed the continuing discussion from 1-29-15 regarding revision within the Bylaws to conform to current practice for how constituencies defined and elected to seats on the Academic Senate. Document ASD 15-21 was reviewed by the body. Document will return for a vote on 2-26-15.

XII. NEW BUSINESS

12.1 ASD 14-194 UPS 100.605 Policy on Administrative Restructuring of Academic Programs [7-11-11] [Source: PRBC]

M/S/P (Mead/Ansari) Motion to approve ASD 14-194. PRBC reviewed and recommended revisions to UPS 100.605 to create continuity and consistency in the process of administrative restructuring of academic programs.

(Jarvis) Line 37, determined *friendly amendment* to read "...which shall make a recommendation to the Academic Senate."

VOTE (by Voice) ASD 14-194, revised UPS 100.605 was approved with friendly amendment.

Chair Walker asked Senator Fischer to speak to UCC memo (ASD 14-191) pertaining to items 12.2, 12.3, and 12.4 prior to AS action.

12.2 ASD 14-99 New UPS 4XX.XXX Undergraduate Project and Thesis [Source: UCC/ASC]

M/S/P (Fischer/Sargeant) Motion to approve ASD 14-191, new UPS for Undergraduate Project and Thesis.

M/S/F (Fidalgo/Michalopoulos) Line 15, revise sentence to remove 7 words as follows. Sentence would read "...consists of individual research done by a student under the supervision of a CSUF instructor, " Debate.

VOTE (by Voice) on proposed amendment - motion failed. Back to main motion.

VOTE (by Voice) Motion to approve ASD 14-99 – passed without dissent (2 abstentions).

- 12.3 ASD 14-191 Memo re Standardization of 495-498 Courses [Source: UCC]
- Senator Fischer, Chair of University Curriculum Committee, framed the discussions for item 12.2 (ASD 14-99) and item 12.4 (ASD 14-191). Ensuing conversation focused on ASD 14-191 UCC memo outline of explanation to standardize courses 495, 496 497 498. The question to be answered: Is it worth the effort for both Academic Programs and all departments affected to go through these aligning changes for numbering. Senator Sargeant stated standardization would improve High-Impact Practice accountability to be able track student enrollment. Currently Internships are under various numbers within departments, so enrollment counts must be done manually. The effort of time and energy would mean important curricular clean-up for the benefit and clarity for departments and students.
- 12.4 ASD 14-192 UPS 411.601 Policy on Academic Internships [7-21-14] [Source: UCC]

M/S/P (Fischer/Fidalgo) Motion to approve ASD 14-192 UPS 411.601 as revised. (Fisher) Line 30, determined *friendly amendment* to add <u>395 or</u> 495. Sentence would read: "*Any course that meets the above definition shall be numbered "395" or "495" at the upper-division undergraduate level and "595" at the graduate level.*"

Senator Myck-Wayne affirmed that adding "395" would give protection to students to work through the Center for Internships and Community Engagement and would be included under II. 2. – Office of Risk Management oversight.

M/S/**F** (Bonney/Casem) Line 68, II.5. motion to change under #II. 5, from six units to nine units. Sentence would read: "5. No more than six <u>nine</u> units of internship credit shall be among...." Debate.

VOTE (by Voice) Motion fails to change the number of internship units from six to nine (2 abstentions). Back to main motion.

VOTE (by Voice) Motion to approve ASD 14-192 UPS 411.601 as amended was approved.

Update on Engineering Exceptions/Deferments/Compliance with 120/180 Title 5 Requirement

I was asked to give an update on the 120/180 exception requests. The following campuses are in compliance with the 120/180 requirement: Bakersfield, Channel Islands, Fullerton, Humboldt, Long Beach, Monterey Bay, San Jose, San Marcos, Sonoma, and Stanislaus.

CSU Los Angeles and Cal Poly Pomona have been given deferments because they are converting from quarters to semesters.

With the exception of the Maritime Academy, which has several high unit programs ranging from 153 – 183 semester units, the average number of units of programs granted an exception were 125 (median 125, minimum 121, maximum 131) semester units. Programs that were 'deferred' and asked to consider ways to reduce further the average number of units of programs given a deferral were 129 (median 129, minimum 127, maximum 132). The details are on the next two pages of this report.
