Topic: Green Open Access Policy Presentation

Presenter: Mark Bilby

Mark Bilby gave a PowerPoint presentation overview of the Green Open Access Policy.

Q: (Casem) What about retroactive?

A: Because this policy changes the legal landscape, it doesn't apply retroactively; it is only forward looking. Once it passes and takes effect, then it would apply.

Q: (Patton) You mentioned that many of us already post our stuff to Research Gate. How do they handle the issue with publishers? Or have publishers not really engaged with them over this?

A: I think most publishers are just letting it happen because they realize it would look terrible to go after faculty for depositing their own journal articles. Some publishers do send take down notices to individual faculty members.

Q: (Sargeant) The policy talks about helping the University obtain electronic copy and about the Library implementing the policy. There is no language of how that will be enforced. Are you anticipating using a system like the UC implementation, an electronic article grabber?

A: This policy empowers anybody at the institution to deposit on your behalf, unless you opt out. If you opt out, then nobody can do anything with your articles; they are your articles. If you choose to participate, then you are saying the Library can deposit your articles. You have the final say; faculty are in control. The policy assumes that most faculty would like to share their articles, but it doesn't force faculty to do so.

The only additions to our already long agenda are the revisions to the UPS documents on our various faculty awards: UPS 290.000 - Outstanding Professor Award; UPS 292.000 - Faculty Leadership in Collegial Governance Award; UPS 293.000 - Carol Barnes Excellence in Teaching Award; UPS 294.000 - L. Donald Shields Excellence in Scholarship and Creativity Award; and UPS 295.000 - The Outstanding Lecturer Award. The Outstanding Professor Committee has revised all of these to clarify the contents of and process for the applications and to provide for electronic submissions. These have been moved to the consent calendar so we can be certain they are in effect for next year. Otherwise the agenda for the Marathon Meeting looks pretty much as it has for the last two meetings.

Chairing our boisterous senate, while it sometimes seems to be an exercise in herding cats (https://www.youtube.com/watch?v=Pk7yqITMvp8), has strengthened my belief that shared governance - a system in which everyone in the campus community has a place at the table - is absolutely essential to a healthy university. Tenure/Tenure-Track Faculty Searches

As of May 12, 2017, our college deans have offered positions to 54 candidates, of which 42 have accepted and 12 have declined. Five remaining offers are pending. We value our new recruits' diverse voices and contributions, and sincerely appreciate their long-term commitment to our campus and to the success of our students.

Recruitment for CSUF's Associate Vice President for Academic Operations will soon come to a close following on-campus visits last week by the three top finalists: **Dr. Sunil Ahuja**, Vice President for Accreditation Relations, Institutional Change, and Research for the Higher Learning Commission; **Dr. Krzysztof (Kris) Slowinski**, Associate Dean for Academic Programs, Evaluation, and Advising, College of Natural Sciences and Mathematics at California State University, Long Beach; and **Dr. Karyn Scissum Gunn**, Interim Provost and Vice President for Academic Affairs for Alabama State University.

12.3 ASD 17-47 Revision to UPS 320.020 - University Writing Requirement

M/S/ (Casem/Fischer) Motion to approve ASD 17-47 Revisions to UPS 320.020 - University Writing Requirement.

M/S/ (Armstrong/Walker) Line 59-60 and 80-81: remove the words "lengthy papers or greater number of shorter ones"

(Stambough) at the end of the sentence add "this requirement may be met by having multiple drafts of the same paper"

(Casem) Reframed the Armstrong/Walker wording. The sentence will now read:

"In intensive writing courses, students shall individually write multiple papers or multiple drafts of a single paper, which involve the organization and expression of complex data or ideas". *Considered friendly.*

Back to main motion

M/S/P (Fitch/Fidalgo) Line 25: strike the first clause from Section B and the sentence will now start at "It is suggested..." Motion passed without objection.

M/S/F (Jarvis/Walker) Line 64 & 86: remove the word "competence"
