VII. CHAIR'S REPORT - written report distributed 5-8-18.

Greetings everyone. We have a lot of work to do and two weeks to do it! Over the next couple of weeks, we start with the unfinished business of UPS 320.020 (University Writing Requirements). So far, the discussion on this topic has been vigorous and substantive. I think we are close to finishing the document which will let us move towards new business.

We do have several items of new business on the agenda. Some of these are relatively quick items. There are two UPS documents listed for rescission. These are old documents that have rarely/never been used. The first concerns ASI policy making and the role of the Senate. The second is a document that was written when I was in Junior High School and, as far as anyone can tell, hasn't been implemented since then. Instead of having policy that no one uses and is fairly unworkable, it has been proposed that the document be rescinded and accompanied by a resolution to direct the Senate to work with HRDI and the Provost to develop a workable procedure for administrative reviews to occur and to include input from faculty and staff.

In addition to the items considered for rescission, we have additional items about courses, formation/discontinuance of our Institutes and Centers, faculty research resources, course outlines, and course absences. This will be a busy time and there will likely be more coming before the marathon meeting as well. Throughout the year, our Senate dealt with a handful of very complex and very important issues. From the revisions to UPS 210 to massive changes to the General Education program, we have done a lot of conceptual and detailed work.

It is often the case that we sequence those two stages so that we spend a year conceptualizing the direction we want to go before handling the details once consensus is developed over the direction. For a number of reasons, we were not afforded that luxury this year. The progress that we made on these issues is great and we will continue to do more in the coming years. None of that is possible without the work of the committees and task forces so I extend a huge thanks to all the members who spent so much time on these matters.

Janus vs. AFSCME:

Unions are a pathway to greater prosperity and rights for working people. Unions have been at the forefront of the fight for civil and worker's rights. The U.S. Supreme Court case Janus v. AFSCME is the latest in a long-term push by very rich, powerful, extreme conservatives to impose elements of "Right to Work" laws that already exist in some states. We know that those laws have led to lower wages, loss of medical care and retirement programs, and increasing income inequality. These losses also have fallen hardest on people of color and Native people. CFA calls on all CSU faculty to join the union, and stand with our all our colleagues to advocate for our profession, for our university, for our students, and for one another.

CFA Lobby Day:

Faculty and students travelled to Sacramento to lobby legislators for more funding for the CSU. The two-day event drew CFA and Students for Quality Education (SQE) members from throughout the state, who lobbied Assembly members and Senators about bills that would improve mental health counseling on campuses (SB 968), establish routine audits of the CSU budget (AB 2505), and improve transparency

related to police investigations (SB 1421). In addition, the union is asking the state to set aside \$50 million for tenure and tenure-track faculty position hires.

CFA has endorsed Gavin Newsom for Governor and Tony Thurmond for State Superintendent of Public Instruction.

- Q: (Walker) I want to make sure there is both a fall and spring approval process?
 A: (Mead) Yes.
- M/S (Meyer/Casem) Line 291, restore the stricken wording "and a fourth time if it is in the new course proposal cycle."
 - ➤ M/S/P (Walker/Fitch) Propose alternative wording for the "Meyer/Casem" amendment; the sentence will now read: "Once approved the special course may be offered up to four times within five years."

• (Patton) Line 130 & 157 inverted the words "courses and proposed," the sentences will now read: "The fall cycle begins on September 1 with the distribution of the list of proposed courses by the Office of Academic Programs". *Considered friendly*.

Back to main motion

- Q: (Kanel) Are we using challenging and questioning synonymously in this document?
 A: (Mead) In the old language there was no distinction as to what they were or how it operated.
 We defined a question, so it proposes there is an opportunity for questionings. The departments, colleges, and Academic Programs can work things out. If they can't work things out, then they have to be turned into a challenge, and it would go through a more formal process.
- Q: (Tsang) If this document is approved, will the current courses that have already been submitted or accepted as a special be grandfathered into this and not reapply again?
- A: (Foster) Yes. We have to work with scheduling to see how the system will recognize them. If you have something pre-approved, we will have to take them on a case-by-case basis for a little while.
- Q: (Fitch) When I was department chair we would always put these dummy courses in because
 the special was not listed and you could not enter it in. So what you are saying is if we pass
 this, the course numbers for the specials will be in the system so you could put those classes in
 like any other class?
- A: (Foster) Yes.
- (Walker) Revise the wording on line 348 to read "Special course proposals must reach (i.e., all prior levels must have approved) the Office of Academic Programs by....". Considered friendly.
