Q: (Fitch) I was struck by one piece at the end of the report where it talks about Ethnic Studies and the Task Force on Ethnic Studies:

"In Support of the Advancement of Ethnic Studies in the California State University reaffirms support for work of the CSU Task Force on the Advancement of Ethnic Studies, urges provosts to make students aware of ethnic studies opportunities on their campuses, and argues for a reinstatement of the moratorium on implementation of policies related to EOs 1100 and 1110 that have an negative impact on ethnic studies."

I know at some campuses like Cal State Long Beach where the implemented unlimited double counting, it pretty much wiped out Ethnic Studies Program because individual departments came up with their own Ethnic Studies classes. It seems like that double counting provision part if EO 1100 could be significantly detrimental to those programs on our campus should that progress. Was there any serious discussion on this?

A: (Bruschke) No. I wish we could have had more discussion on this, but we got to a lot of business at the very end. The bulk of our work was on Ethnic Studies and what Shared Governance means.

- (Stohs) Another background issue is Assembly Member Shirley Weber of San Diego had proposed a bill that all CSU campuses would have to have a course required in that area, and that ends up being a complicated issue because then it's the State Legislature requiring specific courses. The ASCUS Tried to take an opposition against that to some degree, and that bill has been pulled until next year, and it may come back in a different form.
- (Casem) I want to remind all of us of the work that the GE Task Force has completed and the commitment that's within our document, our preliminary report, to maintaining some of our smaller departments like Ethnic Studies.

XII. NEW BUSINESS

6.1 ASD 18-102 Revisions to UPS 210.001 - Recruitment and Appointment of Tenure-Track Faculty

This item was pulled from the consent calendar by Senator Brunelle.

M/S/P (Brunelle/Fitch) Motion to approve ASD 18-102 - Revisions to UPS 210.001 Recruitment and Appointment of Tenure-Track Faculty passed unanimously.

- > (Brunelle) I have a few amendments:
 - Line 271: remove the hyphen from the sentence. Considered friendly.
 - Lines 240, 249, and 294: correct the title to read "Provost/Vice President." *Considered friendly.*
 - Line 222: remove the words "no more than three." Considered friendly.
 - Lines 104-105: remove the last sentence "Members of the DSC may not solicit applications for that search."
- ➤ (Heiner) I have a few amendments:
 - Line 215: Delete the words "or serious candidates." Considered friendly.
 - Line 223: Introduce "whom" between the words "finalists" and "they" on line 223. *Considered friendly*.
 - Lines 234-35: Amend the first sentence to read: "When the DSC has concluded the screening of candidates/semifinalists, it shall, in conjunction with the Chair, identify finalists to be invited to campus for interviews." *Considered friendly*.
 - Line 237: Amend 'their recommendation" to read "the recommendation of finalists." *Considered friendly*.
- 6.2 ASD 17-165 Revision to UPS 410.103 Curriculum Guidelines and Procedures: Academic Programs

This item was pulled from the consent calendar by Senator Powers.

M/S/P (Powers/Fitch) Motion to approve ASD 17-165 Revision to UPS 410.103 Curriculum Guidelines and Procedures: Academic Programs passed unanimously.

(Powers) Line 108: Add the second Monday of April to the end of the sentence. Considered friendly.

M/S/P (Stohs/Fitch) Revision to the amendment, the sentence will now read..."For the first cycle, new program proposals shall be submitted by the first Monday of November and for the second cycle by the first Monday of April."

• (Patton) I would like to suggest we replace the words "first" and "second" with "fall" and "spring." Considered friendly.

M/S/P (Rodriguez/Patton) Motion to approve ASD 18-43 Revisions to UPS 100.700 - Formation, Operation, and Discontinuation of University Institutes and Centers passed unanimously.

- (Patton) Line 32: correct the title Provost and Vice President to Provost/Vice President throughout the document. Considered friendly.
- > (Mead) I have several amendments:
 - Lines 32-35: the text should not be bolded. Considered friendly.
 - Line 33: replace the wording "his/her" with "their." Considered friendly.
 - Line 54: the words "expedited review" should not be capitalized. Considered friendly.

M/S/P (Mead/Myck-Wayne) Delete the words "and PRBC" from line 59.

Back to main motion

- > (Mead) I have several more amendments:
 - Line 97: replace the wording "his/her" with "their." *Considered friendly*.
 - Line 121: since it is part of the paragraph, remove the sub #1. Considered friendly.
 - Line 137: revise the wording to read "Voluntary suspensions shall include a proposed remediation plan with details as to the extent of the operational suspension and CCI reactivation." *Considered friendly.*
 - Line 64-69: I suggested that this section is taken back and reworked for two reasons: 1) it's in part defined as the formulation "Reorganization and Renaming," a notification process doesn't fit there and it is not parallel with the rest of the document. 2) I wasn't quite sure exactly what they were getting at regarding the procedure so that I would suggest Su Swarat's office and PRBC rework this section for next year.
 - Line 88: I would suggest re-looking at that section as well.
- > (Gradilla) Correct the wording "his/her" to "their" throughout the document. Considered friendly.
- > (Childers) I have a couple of amendments:
 - Line 80-81 restore wording that defines an Expedited Review. Considered friendly.
 - Line 21 removes the wording "Committee and." Considered friendly.

12.2 ASD 18-52 Revisions to UPS 100.610 - Program Discontinuance

M/S/P (Mead/Patton) Motion to approve ASD 18-52 Revisions to UPS 100.610 - Program Discontinuance passed unanimously.

- > (Mead) I have a couple of amendments:
 - Line 46: change the word "it" to "its." Considered friendly
 - Line 116: affect academic should be two words. *Considered friendly*.
- (Filowitz) Lines 260 & 354: add the wording "if they exist" to the end of the sentence. Considered friendly.
- (Bonney) Add the UPS 100.250 Definition of An Academic Unit to this document for reference. Considered friendly.

M/S/P (Heiner/Patton) Motion to add language to line 19 "Suspension includes any university action that involves halting or preventing admission to, or enrollment in, an academic unit, or freezing faculty hiring or course offerings." Passed without dissent.

Q: (Fitch) Does moving the deadline from October 1st to November affect when the committee would be evaluating the grant proposals?

- A: (Kanel) No it would not.
 - (Knutson Miller) The recommendations come to me very late in the spring, so they would not affect that academic year.
- Q: (Tsang) Does lecturers fit into the description of full-time faculty as defined in this document? A: (Stambough) No, it's just Tenured/Tenure-Track.

- (Kanel) Line 4: add the word "catalog" so the sentence will read "….course catalog descriptions…" Considered friendly.
- > (Casem) Line 31: remove the "+" sign from the sentence. Considered friendly.
- > (Childers) Line 44: the correct URL is <u>http://fdc.fullerton.edu/teaching/syllabus.php</u>

- ➢ (Fitch) Add wording to line 18 "or to participate in a professional conference." Considered friendly.
- > (Tiwari) Add academic competitions line 18. Considered friendly.
- > (Filowitz) Line 32 wording instead of the chair being an administrator.
- > (Tiwari) Add program coordinators to administrators. *Considered friendly*.
- > (Jarvis) Line 19 after the wording "or" add the words "at the." Considered friendly.

 - Line 72: the word "under" should be "undergo." *Considered friendly*.
 - Line 68: revise the wording of the sentence so the paragraph is parallel to the other two paragraphs and the sentence will now read "Lecturers not undergoing a six-year, or three-year evaluation will undergo annual periodic evaluation." *Considered friendly*.
 - (Filowitz) Add language to line 22-24 "baring circumstances beyond a lecturer's control." Considered friendly.
 - > (Mead) I have a few amendments:
 - Line 62: change the word "intersession" to "winter session." Considered friendly.
 - Line 186-187: the wording should not be italicized. Considered friendly.
 - Line 41: change the sentence to read "The article of the Collective Bargaining Agreement that addresses appointments." *Considered friendly*.

- (Jarvis) Line 385: add the wording "provided by the lecturer" to the sentence. Considered friendly.
- > (Filowitz) Line 54: remove the word "Associate." *Considered friendly*.
