#### <u>Q&A</u>:

Q: (Buck) How will you interact with the city, community and surrounding residents? Are you working with the city and different elements in the city including the bicycle committee? The bicycle routes headed to campus are critical, and on the Master Plan, there is bicycle/pedestrian bridge suggested across the 57 Fwy which opens up all sorts of other opportunities.

A: That is a crucial point that all the stakeholders are involved. In Sacramento we brought a member of the city planner to the team, we have done the same here, and a city planner sits on our committee. We invite all of our constituents, we have city and county people involved in the committee, and they sit on the oversight committee. They will be part of the process during the whole process.

Q: (Fitch) Among the problems of the 40-year-old buildings the lights are either all the way on or all the way off, you cannot dim them. We have the best technology on campus, but it becomes challenging to use without carrying lamps into class.

A: All the tiny things matter, and it is imperative for us to address them and the Master Plan will look at the condition of all our buildings. In the meantime, we are taking the initiative to try and solve some of those problems. But if there is anything specific send it to us through the work order system, at least we will look at it, and if it is not do-able to fix it right now, we will let you know. If it is something that is within our reach, we will fix it.

#### VII. CHAIR'S REPORT - written report distributed on 4-3-18.

Welcome to the home stretch. Spring break is behind us and, as I've heard in many circles, May is not a month. May is just a few hectic weeks before graduation! As we start our work in April, I wanted to thank those who managed the meeting for me before Spring Break as I handled some eldercare issues. It really helps to have a great team and I thank those who made it possible.

I also want to thank all of the senators who voted via email to approve the Search Committee for the Associate Dean positions in the Library. The process worked as shared governance should. Someone had a concern, people spoke to each other, worked out the issue by sharing information, and then collectively we acted without even being in the same room to get those searches moving. The swift and supportive work of everyone is what makes shared governance a source of pride.

This week we have a short presentation about the Physical Master Plan. This is, obviously, an important part of the campus future as we determine priorities and plans for space use and other related strategies so we can better serve students, promote faculty and staff success, and engage with the greater community as an intellectual and cultural center of Orange County. We will also consider several UPS revisions concerning everything from Alcohol use by students, to program discontinuance procedures (the two items are unrelated!).

I also want to thank everyone for their interest and feedback to the Strategic Plan. It is a work in progress and receiving feedback at this early stage is an important step. Early and frequent consultation is an important step in shared governance. By the next time people are asked for feedback, I suspect the Strategic Plan will be at a stage of fuller development because the task force has valued and sought input. It is our responsibility to continue to provide that input so the task force can produce a plan that represents the best of what we strive to be over the next five years.

Finally, I want to update everyone on some items for the future. First, the Chancellor's Office is in the early stages of revising the Executive Order on Internships. Our Internship and Service Learning Committee under the leadership of committee chair, Mark Ramont, is soliciting feedback from internship coordinators on the current Executive Order so we can provide that information to the working group at the Chancellor's Office early. The main reason for the revision is to make necessary adjustments from a legal and risk management perspective. By providing our input from faculty who are directly involved with internship programs, we can make sure that the revisions include a more balanced approach combining a legal perspective and a faculty-driven curricular perspective.

Also, as you know Senate election season is underway. Petitions for the next election have been circulated and submitted. I look forward to a vibrant election season but that might just be the political scientist in me!

#### WASC Reaccreditation

#### Graduation Initiative 2025

- The GI 2025 Advisory Group met on Wednesday, April 4.
- A special thanks to Faculty Academic Senators, including Drs. Merri Lynn Casem, Kristi Kanel, Bill Meyer and Mike Perez, for participation in GI 2025 "Thought Circle" discussions focused on student success and various GI 2025 components. A first meeting held on Thursday, March 22 provided overview of GI 2025 goals, graduation data and GI 2025 Advisory Group work to date. A second meeting scheduled for Thursday, April 5, will focus on faculty and student success.
- Additionally, thank you to Dr. Minerva Chavez for organizing a "Breaking Bread with Provost Kari" series. A discussion scheduled for Thursday, April 12, will focus on GI 2025. #### XI. CFA REPORT - written report distributed on 4-4-18.

An update on the American Language Program (ALP): A group consisting of ALP faculty and CFA representatives met last month in a meet and confer with representatives from CSU and CSUF administrators to discuss the status of the program. CFA proposed that the program be continued for a year so that we can assess its status; however, the offer was rejected and the University has decided to close the ALP. This means that 14 faculty members will lose their jobs. This is very disturbing and should have been brought to the attention of the Academic Senate. This never happened! This is such a miscarriage of justice. ALP faculty and CFA representatives will meet again next week to further the meet and confer process.

Last month CFA held its Equity Conference in Los Angeles. It was the largest participation of Equity Conference members ever. CFA is making Anti-Racism and Social Transformation a central part of its operating philosophy. Keep your eyes open for upcoming sessions on this soon.

Last month at the CSU Trustees meetings, CFA representatives spoke in support of higher funding for the CSU's. <u>GCB Comments to CSU Trustee</u>.

On April 4, CSU will be in Sacramento demanding more money to fund the University.

The upcoming CFA assembly will be happening the weekend of April 12, 2018.
