Our (CSUF's) input goes to the Statewide Senate, they will work with the Statewide Ethnic Studies Council and once that is done it will go to the Chancellor's office, they have the final approval. Next week we will continue the discussion of Ethnic Studies trying to get our campus's best input to the Chancellors office and the Statewide Senate.
 - Q: (Baker) I wanted to confirm that the survey did not go out to the students?

A: (Stohs) I sent the survey to the ASI leaders and administrators to distribute it to students. The Academic Senate office does not have access to student emails to send the survey to them.

• (Baker) This has not reached all students, so I would appreciate it if everyone could talk to students you come across and ask them if they know about it and their opinion as well.
