(Dabirian) An email went out to campus regarding Learning Management Task Force Report. The task force unanimously decided to move forward with Canvas for our next Learning Management System (LMS). There was a report and presentation that was sent out and there is a webpage for the new LMS system, I strongly encourage you to look at it and if you have any questions send them to me.

We are working with the company to make the migration to the new system as easy as possible for our faculty and students. The migration plan is we will have the system run parallel until 2021 and the goal is to have everyone converted by 2021. All community colleges use Canvas so anybody transferring from a community college, which is half of our students, will already be familiar with the learning management system. Also, a lot of our adjunct faculty are already using the LMS in community colleges. We will have lots of training for faculty in spring semester, summer, and fall, we will have whole series of processes for you. There will also be online training available.

We are moving 15,000 courses to Canvas. The company will take your course on Moodle and move it into Canvas. It will not only move your content over, it is going to move your setting over the best it can. It will give you an exception to notify you if something does not move over and ask you how you would like it to be moved, IT will work with the faculty to make sure those exceptions are handled. All of your course materials will be transferred into the new system and ready to go this summer. We will not move courses during the semester, we will move the courses after each semester. A survey will go out to faculty asking them which courses they want moved and which term and IT will do it at the end of that term.
