12.1 ASD 21-22 Revisions to UPS 330.164 Posthumous Degree and Recognition

M/S/P (Casem/Matz) Motion to approve ASD 21-23 Statements of Opinion. Motion passed.

- (Fidalgo) Years ago, the Academic Senate chair would send a summary letter to campus with comments, and it was informative because it put content and context together. Hence, people who are not familiar with the Senate workings could follow and be much more informed. I wonder if that would be something we would bring back? I asked if we should do more outreach to people who are not necessarily involved with the university workings?
- (Jarvis) Amendment to question 2 under both pro and con add the wording: "Academic Senate Standing Committees meet monthly to discuss issues in their respective jurisdictions."
 - After several additional edits/revisions to the Jarvis amendment, the sentence will read:
 - Academic Senate Standing Committees, which meet regularly, should continue to conduct meetings virtually once we return to an on-campus/in-person environment.
- (Stambough) I do agree with the idea of putting together some sort of a cover letter to explain this.
