Q: (Stanley) I was wondering if you could comment on the approved resolution about the suspension of peer observation and SOQs. That is still be fore the Chancellor's office, but is that something personnel committees should be learning more about?

A: (Matz) Yes, after it's approved it is sent out to the distribution list. Then it is up to the universities what they do with that.

Q: (Stanley) Just to clarify, it is not official it's going through several processes, then personnel committees will learn more about it?

A: (Matz) Yes, then it's up to the university.

- (Jarvis) The ASCSU is not a policy making body, it's a policy recommending body. Unlike our Senate
  which drafts the UPS and then the President signs it and it is now the policy of the University, that is not
  how ASCSU works. When they pass something, they send it to the Chancellor. It is not actionable; the
  Chancellor's office would have to issue an Executive Order to do that. When it comes to the campuses,
  the Academic Senate, the President, Human Resources, or whichever relevant body would have to do it.
  ASCSU doesn't have as powerful legislatively abilities as our Senate does.

  - M/S/P (Casem/Wynants) Amendment to the Sheehan/Matz amendment to remove the word "or" and it will read "and experience". Hand vote: yes = 29, no = 9, abstention = 1

• (Jarvis) Line 142: change the word "shall" to "should". Considered friendly.
