Q: (Jarvis) Do we have any intelligence on when some details on AB-928 implementation are coming? The calendar we reviewed at the retreat is notably vague for a lot of the short term the next year and a half.

A: (Matz) It's forthcoming. We're going to be receiving some excellent news on some of the decisions that they've made. So, if you can hold on until next month, we will have more in the report.

We have started to receive our pay raises and the "Covid money." The money came right on time. Thank you, CFA, for working for a strong contract and getting us paid.

This past week, I want to report that I was in Sacramento with CFA Officers and Activists lobbying for the CSU and other CFA issues that we support. We asked for \$90 million to supplement the \$211 million in the governor's budget; \$300 million unencumbered from the state will ensure our 4% raise for next year. The CSU administration has asked us, CFA, to help them. The \$300 million will cover all of the CSUs' financial ask.

CFA and I met with all the constitutional officers, including Governor Newsom, Lieutenant Governor Kounalakis, Attorney General Bonta, Senate Pro Tempore Atkins, Speaker Rendon, Superintendent of Public Instruction Thurmond, and other Senate and Assembly members.

CFA lobbied for some of the bills we support, including AB 2464; divesting public employee pension investments from fossil fuels; establishing a workgroup to research alternatives to CSU campus policing; expanding CSU parental leave to one semester, and other issues. It was a very productive week.

Q: (Meyers) Did CalPERS offer any reason they chose not to provide Covid money to PERS faculty?

A: (Brown) CFA Statewide officers had a meeting with CSU this morning, and that question was asked directly. Supposedly the money would be treated like extra money, changing their retirement benefits. CalPERS said these people are retired, and the way it's been coded, they are not allowed extra money. We asked them directly what codes CalPERS used so we could do our research to find out why FERP faculty were excluded because it's not clear to us either. Nothing we did said that FERP faculty should be excluded from that money. So, we ask for specifics to see how they came to that determination.
