An evaluation is a written assessment of a faculty member's performance. A recommendation report is a position on the personnel action for which the faculty member is being considered. The two shall be kept separate. An evaluation shall not include a recommendation for action. A recommendation shall state in writing both the recommendation action and the reasons for the recommendation". Considered friendly.

 - o Line 610: add the wording "Evaluation and...". Considered friendly.
 - Line 617: reword to read "To prepare a Recommendation Report with a vote tabulation, share it with the candidate, and alert the Chair that the Recommendation Report is available for viewing". Considered friendly.
