Topic: Fiscal State of the University - Spring 2023

Presenter: VP Porter and President Virjee

Before giving the Fiscal State of the University presentation, President Virjee gave a few highlights from the past year.

Last year, we felt validated with the results of the budget cycle. And it was tempting to be upbeat about the amount the CSU received in new funding for this fiscal year. After all, the amounts were not insubstantial, \$410.8 million in new baseline funds to the CSU. Which resulted in a \$44.5 million in new baseline allocation for CSUF. \$1.2 billion in one-time funds for the CSU, which resulted in \$161.2 million in new one-time allocations for CSUF.

The Governor's January proposed budget provided a proposed incremental, ongoing General Fund increase of \$254.5 million for the California State University (CSU). This amount was consistent with the Governor's multi-year compact to fund higher education.

The Governor's proposed \$254.5 million amounts to about 5% of the CSU state allocation, or about 2.5% of the CSU budget. That proposal specifically included: a \$227.3 million increase in new, unallocated funds, \$27 million to support debt service for CSU infrastructure projects. Which is really not new money, but instead, money intended to finance construction already approved by the State but do so with ongoing baseline funding for the debt service rather than pay for it outright and a baseline adjustment of \$0.2 million ongoing for Corporation for Education Network Initiatives in California (CENIC) costs. Which means that really, the new dollars available to the CSU for operations amounts to the \$227.3 million, or just a bit more than 50% of what was allocated last year. With absolutely no consideration of inflation and what it has done to our fixed costs. And what it has done to our employees' buying power.

In response to the Governor's January proposal, the CSU requested more than twice that, seeking \$529 million in new baseline funding. That amount was specifically requested to meet operational costs, help with academic facilities and infrastructure, address workforce investments, support GI 2025, and provide additional funding for student basic needs.

Since its initial budget ask, the CSU has continued to advocate, push, and lobby for the additional \$303 million above the Governor's compact proposal. Because we do not yet have final numbers on what the May Revise will end up looking like, or what the State will actually allocate to the CSU for the coming fiscal year, Alex will share a fiscal update with you based upon what we know so far.

The Chancellor's office has let us know at CSUF that, based upon our enrollment projections for the coming year, that if the compact holds and the 1% in new enrollment funding comes to the Chancellor's office, we should expect about a 1.5-1.75% bump in enrollment funding. And the good news is that our application and acceptance rate for the coming year are both looking very strong and above target.

I want to thank the PRBC for all their hard work throughout the academic year, the vice presidents for working collaboratively on their respective budgets, and CFO and Vice President Alex Porter for coming in, rolling up his sleeves and asking hard questions.

You all know I love the Academic Senate, and I especially appreciate the chance to share and work with you on the important issues of the day for our campus. Budget is always one of them, and so thank you for the opportunity today, and for each time we have done this together. Thank you all for your commitment to our students and thank you for listening.
