 - Q: (Brown) How did they come about renaming the Arboretum? What was the process that went into it?
 - A: (Provost) The process is outlined in my report. The Arboretum used a consultative process,
 - (Debra Lee) The process lasted almost a year and a half. It started with talking with community members and friends of the Arboretum. We issued a survey and the survey had four names, as well as a write in and we took the top names that people felt strongly about, and Botanical Gardens was a big one that people wanted. Then we sent out a survey with two names, either Cal State Fullerton Arboretum of Botanical Gardens or Arboretum Botanical Gardens at Cal State Fullerton. The one that was chosen was the clear winner. We also held five focus groups.

 - M/S/ (Bruschke/Kanel) Motion to approve ASD 24-06 Revisions to UPS 210.070 Evaluation of Lecturers.

Discussion continued on the revisions to 24-06 Revisions to UPS 210.070 - Evaluation of Lecturers, continued with those who were on the speakers list from the February 8th meeting.

- > M/S/P (Landeros/Shepard) Line 275: add wording "required or". Motion passed without dissent.
- M/S/P (Meyer/Casem) Motion to call the question. Motion passed.

Back to main motion

> M/S/P (Scher/Kanel) Motion for the amendments listed below. Motion passed.

Hand vote: Yes = 40, No = 2, Abstain = 2

- Line 608: delete the wording "with the exception of the FAR responsibilities noted below."
- Line 614: delete the wording "produced by FAR."
- Line 615: delete the wording "Should the information provided by FAR be incomplete the faculty member may indicate that as such in the narrative, or provide accurate information at their discretion, and the absence of such material shall not be the basis for lowering the evaluation."

Back to main motion

➤ M/S/P (Walsh/Weismuller) Line 642: reword sentence to read "The standards for lecturers shall mirror the teaching benchmarks for tenure/tenure track faculty in the department personnel standards; and, in no case shall be set higher." Motion passed.

Back to main motion

- M/S/P (Mallicoat/Plouffe) Line 544: insert wording "Lecturers may explain formal or informal mentoring of students, pedagogical workshops they have participated in via the Faculty Development Center or other disciplinary/professional associations, or other work related to Diversity, Equity, and Inclusion." Motion passed as amended without dissent.
 - (Jarvis) Lines 546 & 547: replace the words "can" and "may" with "should". Considered friendly.
 - (Bruschke) Line 552: add wording "This paragraph clarifies but does not add to the criteria and evidence discussed in Section 5." Considered friendly.
 - (Childers) Lines 546 553: make that language a separate paragraph. Considered friendly.

Back to main motion

- ➤ M/S/P (Plouffe/Bruschke) Line 312: add wording "The criteria will be considered completely addressed by the inclusion of two examples from each category. Motion passed as amended.
 - (Bruschke) Change the word "category" to "criteria". Considered friendly.
 - (Plouffe) Line 314: add "1-6". Considered friendly.
 - (Sacco) Line 314: add the word "of". Considered friendly.
 - M/S/P (Shepard/Weismuller) Motion to call the question. Motion passed.

Back to main motion

➤ M/S/F (Sacco/Kanel) Replace "classroom observation report" with "peer observation report" throughout the document. Motion failed.

Hand vote: Yes = 19, No = 23, Abstain = 2
