Before I respond to the Dean's Recommendations/Areas for Growth I want to thank him for recognizing the multiple **Program Strengths** he cited.

Curricular Currency: We currently assess the relevance of the department's curriculum, and I agree with his recommendation that we pay close attention to our faculty-led student assessment to ensure that the curriculum remains current and responsive to industry needs.

Assigning students to faculty advisors: The idea of assigning one full time faculty member to supplement the advisors in the student success center was tried, and I did not feel it was worth the cost, i.e. a course release.

Prioritization of production curriculum and faculty: I am aware of the financial constraints at CSUF and am very appreciative of the search for a production faculty currently underway. That said, I am looking forward to future searches and in the meantime, we continue to augment our part time faculty with highly motivated, skilled, and diverse faculty.

Navigating university policies and procedures: I agree with the Dean's recommendation that "it is essential for the department to proactively adapt to procedural changes and work collaboratively with others to ensure student success." I want to express my thanks to the Dean and his staff for all their hard work and effort in supporting our department in meeting this goal.

Internal Financial controls: The department recognizes the importance of complying with university policies and fiscal procedures and is doing so.

Publicity and alumni engagement: I support the Dean's effort in hiring a Communications, Marketing, and Events Specialist to significantly enhance alumni outreach and public relations efforts. This person would be an extremely valuable add to our department's work in this area.
