# Policy & Advocacy

I served as a policy advisor for the following legislative bills enacted into California law:

SB 416 – Incarcerated Student's Bill of Rights (Ben Hueso – San Diego/Imperial County) This bill seeks to provide protections for some of California's most vulnerable college student populations. SB 416 would amend the Penal Code to protect incarcerated students' access to face-to-face college instruction provided by quality, regionally accredited, non-profit higher education providers, and it amends Title 15 to recognize full-time enrollment in college as a full-time assignment.

AB 2542 – The Racial Justice Act 2020 (Ash Kalra, D – San Jose) This bill prohibits racial discrimination and explicit or implicit bias in sentencing, jury composition, law enforcement conduct, and DA behavior.

SB 118 – Budget Trailer Bill 2020. Ban the Box to Higher Education AN ACT related to post-secondary education; to provide relative to the consideration of criminal history in the process of application and admission to post-secondary education institutions; to prohibit inquiries relative to criminal histories on an initial application form; to provide relative to certain multi-institution applications; and to provide for related matters.

SB 136 – RISE Act 2019 (Scott Wiener, D – San Francisco) – This narrows the application of the 1-yr sentence enhancement. Before this campaign, a prosecutor would add an extra year to your sentence for every time you got the harsher sentence of prison, instead of probation; overwhelmingly impacting Black and Brown people.

AB 45 (2019) – Eliminating Copays in Prisons and Jails (Mark Stone, D – Monterey Bay) People in prisons & jails no longer must pay a copay before they can see a doctor. They can also access durable medical equipment, like diabetic shoes, glasses, and dentures. AB 2533 (2018) by Assemblymember Mark Stone (D-Scotts Valley) – Inmates: indigence. This bill would require that an inmate in a state prison who has maintained an inmate trust account with \$25 or less for 30 consecutive days be deemed indigent. The bill would require that an inmate who is indigent receive basic supplies necessary for maintaining personal hygiene and be provided with sufficient resources to communicate with and access the courts, as specified.

SB 960 (2018) by Senator Connie Leyva (D-Chino) – Department of Corrections and Rehabilitation: suicide prevention: reports. This bill would require the department to submit a report, as specified, to the Legislature on or before October 1 of each year, to include, among other things, descriptions of progress toward meeting the department's goals related to the completion of suicide risk evaluations, progress toward completion of 72 hour treatment plans, and progress in identifying and implementing initiatives that are designed to reduce risk factors associated with suicide.

SB 1393 (2018) by Senator Holly Mitchell & Ricardo Lara (D-Los Angeles) - This bill would delete the restriction prohibiting a judge from striking a prior serious felony conviction in connection with imposition of the 5-year enhancement described above and would make conforming changes. The bill would make additional technical non-substantive changes.
