Subject: Planning, Resource, & Budget Committee Update, Spring 2014
Presenter: Dr. Paul DeLand, PRBC Chair

Dr. DeLand, PRBC Chair, presented a PowerPoint presentation highlighting 2014 semester activities, along with the budget outlook, Chancellor’s Office RFP Programs, and proposed 2014-15 investments per Strategic Plan priorities identified by PRBC and the President’s Cabinet.

Recommendations presented in the PP:

- Continue faculty hiring targeting high quality and diverse candidates using rolling multi-year hiring plans
- Invest in a robust, user-friendly online recruitment platform for faculty searches (replace Brassring)
- Fund “active recruiting” plans, especially in hard-to-hire areas
- Develop and Academic Master Plan by the end of 2015-16
- Develop a plan to improve the professional experience of our contingent faculty
- Alignment of budget allocations to practices demonstrated to support student success
- Support assessment of student learning
- Implement mandatory student advising
- Begin co-curricular program expansion and use of co-curricular transcripts

- Allocate resources for expenditures deemed essential to a successful Interim WASC Report; e.g., for a Director of Writing position.

Chair Walker opened nominations from the floor for full-time Unit 3 faculty nominations for this position. Senator Bedell nominated Senator Jarvis to fill the position. No other nominations were received. Senator Jarvis was elected by acclamation.

[Same as 7.2] Executive Order 1071 delegates presidents the authority to approve options, concentrations, and emphases within a major. The Chancellor’s Office must be notified of changes without the additional step of CO approval.
- ~~7.4 ASD 14-94 University Advancement Committee – Revised Bylaw from UPS 100.001 [Source: UAC]~~
- 7.5 ASD 14-96 Resolution in Support of Using EWP for 2014-2015 for Select Graduate Programs

A similar resolution was passed last year to continue use of .Examination in Writing Proficiency for students to meet the graduate writing requirement. This resolution will continue use of the EWP for one more year – through 2014-15. Academic departments and programs are strongly encouraged to identify courses in their respective master’s programs that could be used as an alternative to the EWP for student demonstration of English writing proficiency.
- 7.6 ASD 14-97 UPS 320.020 University Writing Requirements – Revised [Source: EC]
The Executive Order does not stipulate timing for graduate students to fulfill writing requirements. The revision removes a self-imposed requirement for graduate students to complete the writing requirement within the first nine units of graduate work.
- 7.7 ASD 14-82 [UPS 100.700](#) Formation, Operation & Discontinuance of University Institutes and Centers [4-29-13] [Source: PRBC]
Executive Order 729 covers university centers, institutes and similar organizations. The EO states these are subject to approval of the campus president, following appropriate faculty consultation in accordance with campus policy. PRBC approved recommended revisions to this UPS, aligned with EO.

Chair Walker thanked colleagues for their hard work and many accomplishments this past year.

IX. PROVOST UPDATE (Cruz)

Provost Cruz reminded the body of this weekend’s commencement ceremonies – May 17 & 18. This should be the largest graduating class in the history of CSUF with 10,615 students scheduled to walk over the 2-

day period. The youngest graduate is 19 and the oldest is 79. It's an exciting time, and he hopes to see everyone there!

XIII. NEW BUSINESS

Item 7.4 moved from Consent Calendar.

7.4 ASD 14-94 University Advancement Committee – Revised Bylaw from UPS 100.001 [Source: UAC] M/S (Mead/Stang) Motion to return the number to two (2) student members serving on UAC. This will be a *friendly* amendment with no objection to this revision.

VOTE (by Voice) ASD 14-94 revision to A.S. Bylaw for UAC was approved as amended.

13.1 ASD 14-83 [UPS 210.050](#) Personnel Policy for Full-Time Temporary Faculty [6-16-04] [Source: FAC] M/S/P (Bonney/Jarvis) Motion to approve ASD 14-83, revised UPS 210.050 with a name change to "Recruitment and Appointment of Temporary Faculty" because it now represents consolidation of the recruitment and appointment of temporary faculty. This document is linked with the new UPS 210.070 Evaluation of Temporary Faculty approved by this body 5-8-14. Senator Bonney explained that UPS 210.050 is "contract-driven" and basically replicates language from the CBA. Faculty Affairs Committee has drafted a clear set of guidelines and procedures for this process. The current process for both recruitment and appointment is now codified in this document.

VOTE (by Voice) ASD 14-83 UPS 210.050 Recruitment and Appointment of Temporary Faculty was approved as submitted by Faculty Affairs Committee.

Following the morning break, Chair Walker reconvened the meeting at 10:00 AM.

M/S/P (Walk/Weismuller) Motion to reconsider ASD 14-83 UPS 210.050 Recruitment and Appointment of Temporary Faculty (title changed from Personnel Policy for Full-Time Temporary Faculty).

Chair Walker confirmed that both Senators Walk and Weismuller had voted in the affirmative to approve ASD 14-83.

VOTE (by Voice) Motion was approved to reconsider ASD 14-83, UPS 210.050.

(Hassan) Apologized for missing the consideration and discussion of this document. Senator Hassan suggested the following revisions to ASD 14-83 in track changes version:

- ✓ III.C. Lines 56-59: *Friendly* amendment to add "the CBA and" in the sentence that reads "Such exceptions must be authorized the Provost/Vice President for Academic Affairs and be consistent with the CBA and applicable equal employment opportunity policy and procedures currently in place."
- ✓ V.E. Lines 126-127: *Friendly* amendment to change last sentence to read: "A copy shall ~~also be provided to the Office of Faculty Affairs and Records for placement~~ be placed in the Personnel Action File of the temporary faculty member."
- ✓ V.F. Line 131: *Friendly* amendment was suggested to remove the time-base number of 1.0 since a part-time lecturer could, in special circumstances, exceed 1.0 by .25. Sentence would read: "*In any given semester, the actual workload of a part-time temporary faculty member may exceed his or her contractual time base.*" The body did not consider this *friendly*.

M/S/P (Stang/Matz) Motion to change V.F. Line 132: change the number from 1.0 to 1.25. Last sentence will read "In any given semester, the actual workload of a part-time temporary faculty member may exceed his or her contractual time base, but may not exceed ~~4.0~~ 1.25."

VOTE (by Voice) Motion to approve change from 1.0 to 1.25 was approved.

VOTE (by Voice) Main motion to approve *reconsidered* ASD 14-83 UPS 210.050 as amended was approved.

- 13.2 ASD 14-106 Rescission of UPS 210.060 Personnel Policy for Part-Time Lecturers [1-10-00] [Source: EC] M/S/P (Knutson Miller/Stang) Motion to rescind this outdated 2000 policy statement.
VOTE (by Voice) Motion to rescind UPS 210.060 was unanimously approved
- 13.3 ASD 14-107 [UPS 210.001](#) Recruitment and Appointment of Tenure-Track Faculty [6-18-03] [Source: FAC] **EC offered an amendment within ASD 14-107 [5-13-14]**
M/S/P (Bonney/Walk) Motion to approve ASD 14-107 revised UPS 210.001 retitled from "Recruitment of Faculty". Senator Bonney spoke on behalf of the revisions sent forward by Faculty Affairs Committee, which have been outlined in the 5-3-14 cover memo from FAC Chair Lohman. No major substantive changes have been made but brings document into compliance with CBA. Revisions continue to separate the recruitment and evaluation of faculty.
M/S/P (Bonney/Myck-Wayne) IV.A., Lines 140-141: motion to strike "Chair of the" DSC to align with lines 168-169. Sentence will read "The Department Chair, in conjunction with the ~~Chair of the~~ DSC, is responsible for reviewing the applicant pool and making recommendations regarding finalists to the Dean."
VOTE (by Voice) Motion to strike 3 words on line 141 "Chair of the" from the sentence was approved.
(Hassan) Motion to add language to IV.D., Lines 189-190: The Dean authorizes which candidates will be invited for campus interviews from the list of finalists submitted by the DSC and recommends appointment of faculty to the Vice President.
Motion died for lack of a second.
M/S/F (Jarvis/Bedell) IV.D., Line 190: Motion to add language to clarify which vice president referred to in this sentence. Add words underscored "to the Provost/Vice President for Academic Affairs or the Vice President of Student Affairs, as appropriate."
VOTE (by Voice) Motion to clarify language of vice president in this section FAILED.
M/S/P (Fontaine/Rhodes) Section II, Line 46: add the following 3 words to begin sentence, "Unless otherwise noted, Vice President refers to the"
VOTE (by Voice) Motion to add clarifying language regarding vice presidents (line 46) was approved.
M/S/F (Hassan/Randall) VI, Line 224-225: strike the last line in that paragraph – "...process; ~~however, the DSC may not be comprised solely of faculty who are participating in the FERP.~~" Add a period following the word *process*.
VOTE (by Voice) Motion to strike this portion of the sentence FAILED.
VOTE (by Voice) Motion to approve ASD 14-107 UPS 210.001 as amended was unanimously approved.
- 13.4 ASD 13-101 Resolution re Collegial Governance [Spring 2013] + ASD 13-163 Joint Memo
Chair Walker discussed the progress made over this past year with regard to collegial governance and stated this resolution had been postponed to assess the need for the resolution at the end of 2013-14.
M/S/P (Bedell/Mead) Motion to respectfully request that ASD 13-101 be referred back to Executive Committee for Academic Senate records.
VOTE (by Voice) Motion was unanimously approved to refer ASD 13-101 back to Executive Committee.
- Chair Walker gave an overview of the next two documents that are related. Both UPS 411.600 and UPS 411.601 policies were not aligned with the Executive Order related to internships. Internships & Service Learning Committee was asked to review these policies to consider aligning with the EO 1064. Senator Knutson Miller, spoke on behalf of ISLC regarding revisions (in red) made to UPS 411.600 and UPS 411.601 using language from EO 1064.
- 13.5 ASD 14-115 UPS 411.600 Policy on Service Learning [6-17-08] [Source: ISLC]
M/S/P (Knutson Miller/Dabirian) Motion to approve revised ASD 14-115 UPS 411.600.
VOTE (by Voice) ASD 14-115 revised UPS 411.600 was approved without dissent (1 abstention-Filowitz).
- 13.6 ASD 14-116 UPS 411.601 Policy on Academic Internships [6-16-10] [Source: ISLC]
M/S/P (Knutson Miller/Evanow) Motion to approve revised ASD 14-116 UPS 411.601.

(Carroll) Line 89 *friendly* amendment to delete the #10; Line 91 change #11 to #10.

VOTE (by Voice) ASD 14-116 revised UPS 411.601 was approved.

- 13.7 ASD 14-112 UPS 300.002 Academic Advising Policy [3-9-11] [Source: SALC]
 M/S/F (Jarvis/Walk) Motion to spend 10 minutes to discuss ASD 14-112. This revised policy may need more lengthy discussion than time might allow. Student Academic Life Committee has put in good work, but it may need to carry over next year. Debate.
 VOTE (by Voice) Motion for a 10 minute discussion was not definite. There was a call for division vote.
 VOTE (by Division) Motion failed for a limited discussion of 10 minutes.

M/S (Rhoten/Weismuller) Motion to approve ASD 14-112 UPS 300.002 as revised by SALC. Senator Rhoten spoke to revisions approved by SALC which were based from input received from Academic Advising Committee and Graduate Education Committee. There are substantive revisions to this advising policy to guide advising practices at both undergraduate and graduate levels that strives for a 75% level of student advising, helping to meet requirements of the Strategic Plan.

Debate.

M/S/P (Bonney/Fitch) Section II.D., Lines 94-100: Motion to strike D. (lines 91-93).

VOTE (by Voice) Motion to delete II.D. was approved (lines 91-100).

M/S/P (Rhoten/Weismuller) Add the following sentence under I.A. University Responsibilities. The University shall provide resources and establish and maintain collaborative relationships among all entities involved in academic advising. The current 'A' would become 'B', through J.

VOTE (by Voice) Motion to re-letter University Responsibilities, adding new I.A. and move B forward through J was approved unanimously (lines 30-31).

VOTE (by Voice) Motion to approve ASD 14-112 UPS 300.002 as amended was approved without dissent (1 abstention-Rhodes).

- 13.8 ASD 13-158 rev. 3-21-14 Proposed New UPS – Challenge by Examinations [Source: ASC]
 Chair Walker reminded the body this document had a First Reading 11-7-13 obtaining comments for Academic Standards Committee to deliberate.
 M/S (Filowitz/Kanel) Motion to approve ASD 13-158 rev. 3-21-14 Proposed New UPS regarding challenge exams. Senator Filowitz highlighted the history of this document requested by Executive Committee when MOOCs (Massive Open Online Courses) emerged in 2012 and presented a potential for an onslaught of challenges in various departments and disciplines. Although an onslaught has not happened, Executive Order 1036, approved in 2008, states that each campus shall develop procedures governing awarding credit for challenge examinations, and campus policy should be consistent with the conditions set forth in EO 1036. The Cal State Fullerton catalog (p. 72) contains written verbiage regarding procedures for credit by examination. A form for students to complete is available through Admissions & Records.
 VOTE (by Voice) Motion to approve ASD 13-158 rev. 3-21-14, was approved unanimously. An appropriate number will be assigned to this new policy statement in the 300 level "Student Related Policies" section index.
