- 4. Statewide Academic Senate Report no report submitted.
  - (Kanel) The Statewide senate met and had strong plenary meetings. The Board of Trustees are meeting
    tomorrow to decide whether they're going to align GE. We discussed in detail that it is not a done deal,
    regardless of what you might have heard. The Student Association was very vehemently and adamantly
    opposed to total alignment, so they support the CSU Senate stance to not align the GE Pathway for our
    own first time freshman.

Statewide Senate passed the resolution to have three extra lecturers across all 23 campuses. The logistics of that aren't quite worked out perfectly yet, but they're working on that.

## 5. ASI Report - no report submitted.

• (Adawalla) ASI is currently continuing our alternative consultation process for the ASI Wellness Initiative. If you all have classrooms or students that you would like us to present to, please let us know.

## 6. CFA Report - no report submitted.

- (Brown) I'm so proud of our Academic Senate and our position on CalGETC. CFA has adamantly
  opposed that; we know it will cost lecturer jobs. We have to be very cognizant that policies that happen at
  the Board of Trustees have a negative impact on our members and we have to be active and say
  something. If you haven't had the opportunity to sign up to make a comment at the Board of Trustees,
  please go online and do so at your convenience.
  - (Landeros) They are sending out a link on either Friday afternoon or Monday. The Open forum is on March 26<sup>th</sup>, you can attend virtually if you can't make it in person, or also send an email. It's important to speak on that for CalGETC, especially for lecturers.
  - (Childers) The Board of Trustees Committee on Educational Policy is meeting at 9:00 am on March 27<sup>th</sup>, their agenda is posted at the Board of Trustees website. Included in that agenda are the specific edits that propose to make to Title V, and that does include the full alignment of CSU GE with CalGETC.
  - Q: (Plouffe) Have you gotten a chance to meet with the Provost as your Martch 7<sup>th</sup> CFA report indicated? A: (Brown) Field Representative and I have not had the opportunity with our faculty rights team to meet with the Provost. I am going to put another request out.
  - (Landeros) We were having a meeting on that and they're coordinating CFA representatives and leadership to meet with the Provost and President Alva to deal with those issues and others that have been pending. We have also put together a Lecturers Issue Committee, where we're going to be working with that. I will give you more information on that as well.

  - M/S/ (Bruschke/Kanel) Motion to approve ASD 24-06 Revisions to UPS 210.070 Evaluation of Lecturers.

Discussion continued in Committee of the Whole on the revisions to 24-06 Revisions to UPS 210.070 - Evaluation of Lecturers, with those who were on the speakers list from the March 7th meeting.

- (Kanel) I want to see how the body feels about refraining from making grammatical corrections and just assume that the Cal State Senate is always grammatically correct. If you have a grammatical correction, could you just write it an send it, rather than making a motion on the floor? That would save some time.
- Line 119: delete wording "at their request or" add "lecturer or".
- Lines 242 243: add the wording "or the base of the new range, whichever is higher".
- Line 329: remove wording below from the table and add the wording to Lines 461-467.
  - Continuing professional engagement in the discipline and/or professional development as relevant to teaching assignment(s);
  - Developing new courses
  - Organization of pedagogical workshops
  - Supervision of student research and other forms of mentorship
  - Developing service learning opportunities, community-engaged learning opportunities, and/or semester abroad courses
- Line 330: reinstate the wording "Compliance with University, College, and Department policies governing instructional duties as outlined in faculty handbooks and University Policy Statements".
- Lines 359 360: delete the wording: "that characterize instruction as "exceeds expectations," "satisfactory," etc."
- Line 468: add wording: "Counselors and Librarians".
- Line 544: add the wording: "except for those responsibilities assigned to FAR below".
- Line 548: add the wording: "uploaded by Faculty Affairs and Records".
- Lines 605 609: reinstate wording: "Examples include a representative syllabus for each course taught, class
  assignments, sample papers and/or exams, other instructional material, evidence of grading practices,
  classroom visitation reports, and (where available) signed letters from students. Supporting materials shall
  emphasize quality and representativeness over quantity.

- Line 607: add wording: "screenshots of LMS".
- Lines 642 643: add wording: "produced and distributed by the appropriate dean's office".
- Line 654: delete the wording: "Syllabi for all courses taught for the period under review".
- Line 664: add the wording: "Any required SOQ or grade distribution data for the period of review. FAR will
  support and assist faculty in obtaining these data, including loading the necessary reports into any electronic
  portfolio system and re-naming files as necessary. Submission of the final portfolio is the responsibility of the
  faculty member.
- (Sacco) Line 664: replace the word "any" with "all" and replace the word "or" with "and". Add the wording "for the period of review".
- (Sacco) Line 356: replace the word "provide" with "measure" and delete the wording "evidence of".
- (Henning) Lines 585-587 delete the wording: For example, lecturers working in colleges or departments with accreditation standards may be required to be professionally active and/or engaged in scholarly or creative activity".
- (Henning) Lines 583-585: reword to read: "If the lecturer is engaged in professionally active and/or engaged in scholarly or creative activity, the narrative shall summarize those professional, scholarly, or creative activities".
  - o (Graewingholt) Replace "shall" with "should".
