This morning, I received in my mailbox a printed announcement for the Associate Vice President for Academic Operations. We are in a budget situation and faculty are being told we don't have money for this or that, but they are spending money on printing colored announcements on expensive paper. This is a slap in the face to faculty.
 - Chair Stambough will speak with Provost Puri regarding this matter.
- There are white supremacists who are marching on college campuses and murdering people. It has a chilling effect among communities of color to know those things are happening. I wonder if the Academic Senate might not be a vehicle for affirming a certain set of values that can communicate the cultural openness we expect our students to have.
 - Chair Stambough will speak with Provost Puri and VP Eanes regarding putting together an ad hoc group to put together a statement on the lines between free speech and harassment.
